TITLE: Awarding a forty-five (45) month term and supply contract to end 12/23/2028 with the option to renew for three (3) additional one-year extensions for the Furnishings of Body Armor with Related Accessories, Equipment & Services for use by various County Departments to Galls LLC, under the terms and conditions of Sourcewell Contract No. 091924, an existing, competitively bid government contract.

SUMMARY: Various County Departments require a Term and Supply Contract for the furnishing of Body Armor with Related Accessories, Equipment & Services. Sourcewell contract No. 091924 gives access to the following types of products & services: ballistics, carriers, helmets, accessories, pouches & bags, K-9, shields, blankets, undervests shirts & vest covers, active shooter kits, plates, panels & packs. The 091924 Galls Master Agreement, 091924 Galls Products & Services Overview Page, 091924 Galls Pricing, and using Departments Sped Memos are attached. Sourcewell is a local government unit and service cooperative that facilitates a competitive public solicitation and contract award process for the benefit of government, education, and nonprofit agencies. Cooperative purchasing provides participating entities and suppliers increased administrative efficiencies and the power of combined purchasing volume that result in overall cost savings. Pursuant to Section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the award of a forty-five (45) month term and supply contract to end 12/23/2028 with the option to renew for three (3) additional one-year extensions for the furnishing of Body Armor with Related Accessories, Equipment & Services for use by various County Departments to Galls LLC, under the terms and conditions of Sourcewell Contract No. 091924, an existing, competitively bid government contracts. This award is made on as "As Needed" basis and does not obligate Jackson County to pay
