WHEREAS, the Family Court Division has been awarded an OSCA Domestic Relations Resolution Fund (DRRF) Mediation grant in the amount of \$10,000.00 by the Missouri Office of the State Courts Administrator, for the 2026 fiscal year, with an additional fund amount of \$5,250.00; and,

WHEREAS, the grant funds will be used for the implementation of domestic relations programs; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,
