# **COOPERATIVE AGREEMENT**

THIS AGREEMENT, made by and between JACKSON COUNTY, MISSOURI, a Constitutional Home Rule Charter County of the First Class of the State of Missouri, hereinafter referred to as "the County" and a Missouri not-for-profit corporation, UNITED INNER CITY SERVICES 2008 E. 12TH ST PO BOX 270538 KANSAS CITY, MO 64127, hereinafter referred to as "Organization".


WHEREAS, the County and Organization desire to enter into an Agreement to provide funding to be used for St. Mark Child and Family Development Center; and,

WHEREAS, the County deems it to be in the best interest of its citizenry to support such programs and activities; and,

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Organization respectively promise, covenant, and agree with each other as follows:

**NOW, THEREFORE**, it is agreed by and between the parties as follows:

- 1. <u>Services</u>. Organization shall provide services St. Mark Child and Family Development Center, as is more fully set out in the proposal attached hereto as Exhibit A and incorporated herein by reference. The term of this contract is January 1, 2019, through December 31, 2019, and as such, all expenditures must occur within this period. The budget Organization submitted as part of Exhibit A is considered final and non-changeable.
- 2. <u>Terms Of Payment</u>. The County agrees to pay Organization the total amount of \$358,000.00 in quarterly installments of \$89,500.00, with the payment for the



first quarter in advance upon execution of this Agreement; this is the <u>ONLY</u> payment that may be made in advance throughout the entire term of this Agreement. The remaining payments shall be made upon the County's receipt of the quarterly reports as set forth in paragraph 3 hereof. The County reserves the right to audit all invoices and to reject any invoice for good cause. The County retains the right to deduct from an invoice of Organization any overpayment made by the County on a prior invoice. The County retains the right to make invoice corrections/changes. The County will not reimburse sales tax expense.

3. Reports/Other Documentation. Within 30 days after the conclusion of each calendar quarter under this Agreement, Organization shall submit a quarterly reconciliation report through the Outside Agency Portal along with proof of payment and receipt documentation that reconciles to the quarterly report, including cancelled checks and/or a copy of the face of the check and corresponding bank statements, invoices. and any other documents requested by the Department of Finance and Purchasing, to establish that the funds provided pursuant to this Agreement were used for the purposes set forth herein. The report for the first quarter must be submitted within 30 days after the execution of this Agreement. The last quarter's report shall include an annual report which shall summarize all of Organization's activities pursuant to this Agreement. Organization's failure to submit this annual report shall disqualify Organization from future funding by the County. Organization must submit all quarterly reconciliation reports in the format specified by the County regardless of whether activity took place in each quarter, before the next quarterly payment will be processed. Any quarterly reports that are incomplete or incorrect will delay payment.

Organization must notify the County in writing on Organization's letterhead, within five working days of the following changes:

- a. Organization name, address, telephone number, administration, or board of directors
- b. Organization funding that will affect the program under this contract
- c. Liability insurance coverage
- d. Management or staff responsible for providing services pursuant to this contract. When a management or staff position responsible for providing services pursuant to this contract is vacated and when the position is subsequently filled, the following will apply i.) reimbursement for a vacated position will be suspended until it is filled, and ii.) if another person under this contract assumes the duties of the vacated position, the Organization will not be allowed to bill the County for both positions.
- e. Any proposed or actual merger or acquisition either taken by the Organization or toward the Organization
- 4. <u>Submission of Documents</u>. No payment shall be made under this Agreement unless Organization shall have submitted to the County's Department of Finance and Purchasing through the Jackson County Outside Agency portal accessible on <a href="www.jacksongov.org/auditor">www.jacksongov.org/auditor</a>: (1) a written proposal setting out in detail the intended use of the County's funding, including the target population to be served; (2) Organization's IRS Form 990 from the previous fiscal or calendar year; (3) a statement of Organization's total budget for its most recent fiscal year; and (4) a detailed explanation of actual expenditures of the County's funds (pertains to final payments and payments on contracts for future years). If Organization has previously received funding from the County, to be eligible for future payments, Organization must submit either an audited financial statement for Organization's most-recent fiscal or calendar year, or a certified public accountant's program audit of the County's funds. Any documents described herein which were submitted to the Department of Finance and Purchasing as a part of an application for funding need not be resubmitted to qualify for

payment. No payment shall be made if Organization is out of compliance on any other County contract, or has not paid county taxes on all properties owned by Organization and assessed by the County.

- 5. **Equal Opportunity**. Organization shall maintain policies of employment as follows:
  - A. Organization and Organization's subcontractor(s) shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, age, disability, or national origin. Organization shall take affirmative action as set forth to ensure that applicants for employment and employees are treated without regard to their race, religion, color, sex, age, disability, or national origin. Such action shall include, but not be limited, to the following: recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. Organization agrees to post in conspicuous places, available to employees and applicants for employment, notices setting forth the policies of non-discrimination.
  - B. Organization and Organization's subcontractor(s) shall, in all solicitation or advertisements for employees placed by them or on their behalf, state that all qualified applicants will receive consideration for employment without regard to race, religion, color, sex, age, disability, or national origin.
- 6. <u>Employment Of Unauthorized Aliens Prohibited</u>. Pursuant to §285.530.1, RSMo, Organization assures that it does not knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the State of Missouri and/or Jackson County, and shall affirm, by sworn affidavit and provision of

documentation, its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services. Further, Organization shall sign an affidavit, attached hereto and incorporated herein as Exhibit B, affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services.

- 7. Audit. The parties agree that the County may, for any reason and at any given time, examine and audit the books and records of Organization pertaining to this Agreement. Further, Organization agrees to establish and adopt such accounting standards and forms as recommended by the County prior to receipt of the County's first distribution of funds under the terms of this Agreement. The forms used to document expenditure of these funds may be changed from time to time by the County.
- 8. <u>Default</u>. If Organization shall default in the performance or observation of any covenant, term or condition herein contained to be performed by Organization, the County shall give Organization ten days written notice, setting forth the default. If said default shall continue and not be corrected by Organization within ten days after receipt of notice from the County, the County may, at its election, terminate this Agreement and withhold any payments not yet made to Organization. Said election shall not, in any way, limit the County's rights to sue for breach of this Agreement.
- 9. Appropriation Of Funds. Organization and the County recognize that the County intends to satisfy its financial obligation to Organization hereunder out of funds annually appropriated for that purpose by the County. County promises and covenants to make its best efforts to appropriate funds in accordance with this Agreement. In the event no funds or insufficient funds are appropriated and budgeted, or are otherwise

unavailable by any means whatsoever for payment due hereunder, County shall immediately notify Organization of this occurrence and this Agreement shall terminate on the last day for which appropriations were received, without penalty or expense to the County of any kind whatsoever, except as to the portions of the payment amounts herein agreed upon for which funds shall have been appropriated and budgeted or are otherwise available, or at any time after the last date that County has paid for the Services, if earlier.

## County further agrees:

A. That any funds authorized or appropriated for services rendered under this Agreement shall be applied to the payments hereunder until all such funds are exhausted.

- B. That County will use its best efforts to obtain authorization and appropriation of such funds including, without limitation, the inclusion in its annual budget, a request for adequate funds to meet its obligation under this Agreement in full.
- 10. <u>Conflict Of Interest</u>. Organization warrants that no officer or employee of the County, whether elected or appointed, shall, in any manner whatsoever, be interested in or receive any benefit from the profits or emoluments of this Agreement.
- 11. <u>Severability</u>. If any covenant or other provision of this Agreement is invalid, or incapable of being enforced by reason of any rule of law or public policy, all other conditions and provisions of this Agreement shall, nevertheless, remain in full force and effect; and no covenant or provision shall be deemed dependent upon any other covenant or provision unless so expressed herein.

- 12. <u>Indemnification</u>. Organization shall indemnify, defend and hold the County harmless from any and all claims, liabilities, damages, and costs (including reasonable attorney's fees directly related thereto) including but not limited to violation of civil rights and/or bodily injury to or death of any person and for damage to or destruction of property if and to the extent caused by the negligence, willful misconduct or omissions of Organization during the performance of this Agreement.
- 13. <u>Insurance</u>. Organization shall maintain the following insurance coverage during the term of this Agreement.
- A. Organization shall maintain Commercial General Bodily Injury and Property Damage Liability insurance, each in a combined single limit of One Million Dollars (\$1,000,000) each occurrence for bodily injury and property damage liability.
- B. Organization shall maintain, if any motor vehicles are used in the performance of the Services, Commercial General Bodily Injury and Property Damage Liability insurance, and Automobile Liability insurance including owned, non-owned, or hired vehicles, each in a combined single limit of One Million Dollars (\$1,000,000) each occurrence for bodily injury and property damage liability.
- C. Organization agrees to provide the County with certificates of insurance evidencing the above described coverage prior to the start of Services, and annually thereafter, if required by the County. Such certificates shall provide that the applicable insurance policies have been endorsed to provide a minimum of thirty days advance notice to the County in the event of cancellation, non-

renewal, or reduction in limits by endorsement.

- 14. <u>Term.</u> The term of this Agreement shall commence January 1, 2019, and shall continue until December 31, 2019, unless sooner terminated pursuant to paragraph 8, 15, or 19 hereof. If this Agreement is terminated by either party, the County shall pay only for those services actually performed by Organization as verified by the County's audit.
- 15. <u>Termination</u>. This Agreement may be terminated for any reason or no reason by either of the parties upon thirty (30) days' written notice to the other party's designated fiscal representative. All services and payments shall continue through the effective date of termination. Termination of this Agreement shall not constitute a waiver of the rights or obligations which the County or Organization may be entitled to receive as provided in this Agreement, or be obligated to perform under this Agreement for services prior to the date of termination. Should this Agreement terminate, all County written materials of any kind must be delivered and returned by Organization to the County within ten (10) days of the termination of this Agreement.
- 16. <u>Standard of Care</u>. Organization shall exercise the same degree of care, skill, and diligence in the performance of the Services as is ordinarily possessed and exercised by professionals operating under similar circumstances.
- 17. **Financial Contact.** Organization shall designate a fiscal representative to act as a liaison between the parties to resolve any problems, complaints, or special circumstances encountered in the billing of the services agreed upon here.

- 18. Affirmative Action Compliance. The performance of this Agreement shall be subject to review by the County. The County Compliance Review Officer shall review this contract according to his responsibilities as set out in Chapter 6 of the Jackson County Code. Organization shall file quarterly compliance reports as required by the County Compliance Review Office. The County warrants that all books, records, accounts, and any other documents in the possession of the County relating to this Agreement are public records open for inspection in accordance with Chapter 610, RSMo.
- 19. Remedies For Breach. Organization agrees to faithfully observe and perform all of the terms, provisions, and requirements of this Agreement, and Organization's failure to do so constitutes a breach of this Agreement. In such event, Organization consents and agrees as follows:
- A. The County may, without prior notice to Organization, immediately terminate this Agreement; and
- B. The County shall be entitled to collect from Organization all payments made by the County to Organization for which Organization has not yet rendered services in accordance with this Agreement, and to collect the County's reasonable attorney's fees, court costs and service fees if it is

necessary to bring action to recover such payments.

- Transfer And Assignment. Organization shall not assign or transfer any portion or the whole of this Agreement without the prior written consent of the County.
- 21. Organization Identity. If Organization is merged or purchased by another entity, the County reserves the right to terminate this Agreement. Organization shall immediately notify the county in the event it is merged or purchases by any other entity.
- 22. Confidentiality. Organization's records concerning the identities of those participating in its programs shall be strictly confidential; the County shall be entitled to examine said records in performing its audit and review functions, but shall not disclose said identities to any third party in any fashion.
- 23. Incorporation. This Agreement incorporates the entire understanding and agreement of the parties.

Provide program description: "Building bridges, inspiring minds, and impacting futures," is the refreshed mission of United Inner City Services (UICS). These are the concrete actions UICS takes every day to achieve its vision: to create a community where children thrive and families flourish. For fifty-one years, UICS has served as an anchor to Kansas City, Missouri's 12th Street Corridor just east of downtown, strengthening the health and vitality of its neighboring communities. In 1972, UICS responded to the growing demand for quality childcare. By 2004, key Kansas City leaders and community partners erected St. Mark Child & Family Development Center. Since then, its highly credentialed teachers, child-centered curriculum, and arts-infused behavioral interventions have helped it achieve its mission. Seizing the opportunity presented during the most formative years—0 to 5—leads to a lifetime of superb physical, social/emotional, and cognitive health, building a firm foundation for future success. St. Mark Center, an outreach of UICS, is a highquality early learning center for infants, toddlers, and pre-Kindergarten students. Serving 150 children annually, our state-of-the-art facility is outfitted to support the provision of a distinctive, arts-infused curriculum, which has been shown to improve learning outcomes, help children express and manage their emotions, improve communication, and stimulate healthy brain development (Brown, E. D., Sax, K. L., 2013). UICS/St. Mark Center's curriculum is child-centered, supported by highly credentialed teachers and staff, and is uniquely infused with a focus on the arts. In addition to early childhood education, families have access to parent advocates and supportive services. In 2019, UICS will begin operating a second facility at 39th and Troost in partnership with the Kansas City Area Transit Authority (KCATA). This new space will afford the opportunity for UICS to support an additional 110-120 children daily as well as begin operating programs for second-shift employment families with late evening hours of operation through 11:00pm or 12:00am. Additionally, this new location will enable a more diverse economic base of families with the ability to draw upon the Hyde Park and Squier Park neighborhood residents along with attracting professional families seeking a quality early learning experience that we are not able to presently accommodate, due to space constraints. Our waiting list is abundant (double check what the %% of I/T and Preschool is currently). Additional funding is requested from the Jackson County Outside Agency funding opportunity that will help in hiring the Center Director of what will be known as the UICS-Metro Center and will help to facilitate this expansion offering a bridge of funding during the ramp-up phase of the expansion. To enhance our programmatic focuses of early childhood education, community engagement, and Arts@St.Mark, UICS is proud to be launching two new partnerships that will strengthen outcomes for our students and families: The Urban League's 2018 "State of Black America" report reveals Black Americans are woefully underrepresented in science, technology, engineering, and math careers and make up less than 5% of the workforce in tech companies. In partnership with PNC Bank and Science City, St. Mark is incorporating STEAM principles into the curriculum in the coming year. The new "STEAM for All!" initiative is dedicated to reducing the disparities in minority representation in the fields of Science, Technology, Engineering and Math (the added 'A' stands for Arts). Studies show that mathematical achievement in Kindergarten, for instance, is a greater predictor of long-term math and literacy gains than teaching literacy alone (Early STEM Matters: Providing High-Quality STEM Experiences for All Young Learners, Early Childhood STEM Working Group, 2017). Understanding of STEAM concepts begins as soon as a child can stack blocks, explore their environment, or use an iPad. Exposure to STEAM principles at the earliest stages of life is critical for long-term academic achievement. This school year, St. Mark entered into a year-long partnership with the Nelson-Atkins Museum of Art to have their education staff visit the center once a week in four-week blocks. Every four weeks, visiting educators will rotate from classroom to classroom, implementing child-centered arts programming, culminating in a field trip to the museum. Additionally, the Nelson-Atkins staff will join Stay, Play & Learn sessions each quarter, working with families in art projects alongside their children.

Describe the benefits of this program to Jackson County Missouri: UICS' strategic goal is to fill an early-education gap in Jackson County and ensure that families are afforded an opportunity for a quality early learning experience that does not force them to make compromises based on the cost of the care. Compared with schools, early-learning centers like St. Mark (which teach 84 percent of Jackson County children) lack a tested and proven early education model that would improve kindergarten readiness and outcomes. Missouri is one of only eight states without a framework for assessing the quality of early childhood education. Only 14% of centers in Jackson County are accredited, while school-based programs are far more likely to be accredited, use a curriculum, and assess teachers' effectiveness and children's learning milestones. St. Mark Center's strong curriculum meets the comprehensive developmental needs of Jackson County's children and provides community services for at-risk families we serve. St. Mark Center is the only Head Start affiliated, early childhood development provider with regularly scheduled hours and consistent services in the neighborhood and the only N.A.E.Y.C. accredited program in the 64127 zip code. The Center ensures that all developmental needs of children ages 6-weeks to 5-years are met. Recognizing that the early childhood years are a window of opportunity for dramatically shaping a young person's lifelong path, but are also a window of vulnerability to poverty and its associated risks, UICS provides an array of solutions and interventions to address the problems faced by families in the community. The expansion to the 39th and Troost location will provide the opportunity to support families from a larger geographic area and attract families of diverse backgrounds both economically and racially. An investment in early childhood education for the most vulnerable children in our community will significantly minimize the financial and social cost later through better educational outcomes and school completion. Estimates of \$1 invested in early childhood education range from \$4 to \$17. One well-known study, the HighScope Perry Preschools Study, found that individuals who were enrolled in a quality preschool program ultimately earned more than \$2,000 more per month than those who were not. Young people who were in preschool programs are more likely to graduate, to own homes, and have longer marriages. Children in quality preschools programs are less tikely to repeat grades, need special education, or get into future trouble with the law. With your support, UICS is shaping Jackson County's leaders today.

**Describe target population to be served:** Of the enrolled students and their families we serve, the majority live in the 64106 and 64127 ZIP codes, one of the most disadvantaged neighborhoods in Jackson County/Kansas City (MO) with a 40% poverty rate. More than one-third of households within a 20-block radius of St. Mark have an annual income of less than \$15,000; 40% do not own a vehicle. Nearly half the adults in the neighborhood served do not have a high school diploma. Seventy-nine percent (79%) of those served are African-American, with 87% of the children living in single-parent households in which the poverty rate climbs to 63%. One-third of our parents are under the age of 25. Of the current enrollment, 14 children are identified as homeless and approximately 70% receive Medicaid. Eighty-seven percent (87%) of children enrolled are eligible for free/reduced meals, and more than one-third of families served reside in subsidized housing.

What are the qualifications for participants: Services are available to all families in Jackson County. However, to qualify for Head Start a family must meet specific eligibility criteria including household income requirements less 180% of the federal poverty level.

#### **Outcomes**

Outcome: By June 30, 2019, 90% of five-year-olds transitioning to kindergarten will have improved DRDP measures.

How will outcome be measured: UICS will analyze the DRDP ratings for five-year-olds from fall, winter, and spring to assess and document growth.

Outcome: By June 30, 2019, Improved parental understanding of developmental milestones and performance of their child, particularly targeting parents with low engagement in current family engagement programs and services.

How will outcome be measured: Dashboard results tracking participation at events and educational opportunities throughout the school year. Surveys and Learning Genie usage measuring parent knowledge and skills of their child's development

Outcome: At least one area child development program within the St. Mark Center service area will show demonstrated improvement (in accreditation, environment, instructional quality) in the areas identified during goal setting.

How will outcome be measured: Coaching notes, administration of rating scales, receiving accreditation, and/or survey results with partner programs showing growth in areas identified in quality improvement plans.

Outcome: UICS will demonstrate increased operational and fiscal capacity to deliver high quality early learning services. Increase total revenue of at least 5% by implementing a comprehensive development plan, strategic plan, and marketing/advertising/branding/communications plan. Baseline revenue is \$2,866,247, FY 2017.

How will outcome be measured: As measured by financial records.

Outcome: By Dec 31, 2019, UICS will operate the 39th & Troost location at full capacity, with 110 students enrolled and employing at least 15 additional educators.

How will outcome be measured: As measured by enrollment and employment records.

### WORK AUTHORIZATION AFFIDAVIT

As a condition for any service provided to the County, a business entity shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services.

The term "business entity" shall include but not be limited to self-employed individuals, partnerships, corporations, contractors, and subcontractors. The term "business entity" shall include any business entity that possesses a business permit, license, or tax certificate issued by the state, any business entity that is exempt by law from obtaining such a business permit, and any business entity that is operating unlawfully without such a business permit.

Every such business entity shall complete the following affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services. The completed affidavit must be returned as a part of the contract documentation.

This affidavit affirms that **United Inner City Services**, is enrolled in, and is currently participating in, E-verify or any other equivalent electronic verification of work authorization operated by the United States Department of Homeland Security under the Immigration Reform and Control Act of 1986 (IRCA); and, **United Inner City Services**, does not knowingly employ any person who is an unauthorized alien in conjunction with the contracted services.
