Agenda Title: Approval is recommended to enter into a Cooperative Agreement with the Independence Police Department and the Jackson County Parks and Recreations Department related to a proactive approach to provide an enhanced level of service for those utilizing the Little Blue Trace Trail.

Recommendation: The Police Department recommends approval of this agreement.

Background: The Independence Police Department believes in a commitment to provide an enhanced level of services for those living in and visiting our community. An important resource that provide opportunities for an enjoyable outing and assists in maintaining a healthy life style are the parks, recreational facilities, and trails within our community. The Little Blue Trace Trail it a wonderful resource which is located in Independence, and is a part of the Jackson County Parks and Recreational Department. To ensure the trail remains a safe and secure environment for individual and family outings, the Volunteers in Police Services within the Independence Police Department will provide routine patrol or monitoring of the trail. This program is a cooperative effort with the Jackson County Parks and Recreation Department to implement a pilot program where monitoring of the activities along the trail will be conducted by members of the VIPS Program utilizing a John Deere "Gator to travel the 12 mile trail. In addition to monitoring the activities on the trail, the VIPS will also provide services that will include, providing first aide supplies, water, equipment for minor repairs for bicycles, transportation to access areas for those needing this service, monitoring of maintenance requirements on the trail. Police Radios will be available for notifications on any events requiring additional assistance, and the activities and services provided during this program will be documented to allow for an evaluation of the effectiveness of this program will.

SUBJECT: Cooperative Agreement

This Memorandum of Understanding establishes that Jackson County Parks and Recreation (JCP&R) has entered into an agreement with the Police Department for the City of Independence (IPD), regarding a one year "pilot program" for the patrol of the Little Blue Trace Bike Trail by volunteers through the established Volunteers in Police Service (VIPS) program.

This cooperative agreement is being created to provide an expanded level of service to the visitors of the Little Blue Trace Bike Trail.

The following guidelines have been agreed upon by JCP&R and IPD.

The Independence Police Department agrees to provide the following to the Jackson County Parks and Recreation Department:

1. A point of contact within IPD.

2. The patrol of the Little Blue Trace Bike Trail by supervised volunteers of the City's VIPS program

3. The patrol of the Little Blue Trace by either bicycle or by a vehicle approved by the Parks and Recreation Department

4. The routine maintenance and transportation of any vehicles provided by JCP&R for the patrol of the Bike Trail

5. An advanced (weekly updated) schedule, when know, will be provided (submitted in advance,) for all patrols of the Little Blue Trace, however the program will not be impeded when patrols were not scheduled in advance

A weekly summary (format approved by JCP&R) of the activities witnessed and the services
provided by the Independence Police Department and its volunteers and any and all actions taken
beyond the patrolling of the Bike Trail

7. Proof of liability insurance in the amount of \$1,000,000, listing Jackson County as co-insured

8. To recognize JCP&R and the County, in a pre-approved manner by JCP&R, in all public information regarding this cooperative effort

 Clearly identify all vehicles provided by JCP&R with markings identifying it as a vehicle of the Independence Police Department and a service of Jackson County

10. Equip all vehicles with a radio, (cell phone), first aid supplies and water cooler

11. Provide training for all volunteers on vehicle operation

12. Conduct a (continuing) survey(s) of Little Blue Trace Park patrons to evaluate the success of the increased visitor service being provided by this cooperative effort

13. Provide all supplies and equipment (other than a vehicle provided by JCP&R) for the administration of this program

14. Return all vehicles provided by JCP&R on or before November 1, 2004 unless the program is mutually extended later into the year.

15. Provide routine vehicle maintenance to all vehicles provided by JCP&R

16. Replace all damaged or stolen vehicles provided by JCP&R
