AN ORDINANCE appropriating \$23,000.00 from the fund balance of the 2008 Anti-Drug Sales Tax Fund to restore the 2006 funding level to Guadalupe Center, and authorizing an amendment to the current contract with Guadalupe Center, at a cost to the County not to exceed \$23,000.00.

ORDINANCE #4029, September 15, 2008

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, in fiscal year 2006, Guadalupe Center failed to comply with fiscally related funding requirements, and because of that failure the former COMBAT Commission recommended that its treatment funding be reduced by more that 20%, or \$23,000.00; and,

WHEREAS, at the time County staff assured Guadalupe Center that if the reimbursement forms which Guadalupe had failed to properly fill out were appropriately completed for the deficient period, the previous level of funding would be restored; and,

WHEREAS, due to staff turnover, this commitment was never fulfilled and Guadalupe's revised status was never reported or recorded; and,

WHEREAS, the Executive Transition team recommends this expenditure to fulfill the prior commitment; and,

WHEREAS, an appropriation is necessary to place the funds in the appropriate spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made from the fund balance of the 2008 Anti-Drug Sales Tax Fund:

FIRST ADDENDUM TO AGREEMENT (COMBAT Prevention)

THIS FIRST ADDENDUM TO AGREEMENT is entered into this and day of Colober, 2008, by and between JACKSON COUNTY, MISSOURI, a Constitutional Home Rule Charter County, hereinafter referred to as "the County" and GUADALUPE CENTER, INC., 1015 Avenida Cesar E. Chavez, Kansas City, MO 64108 (a not-for-profit corporation), hereinafter referred to as "Organization."

WHEREAS, by Ordinance 3998, dated June 2, 2008, the Jackson County Legislature authorized the County to enter into an agreement with **Organization** for the purpose of preventing drug and drug-related offenses, at a total cost to the County not to exceed \$40,000.00; and,

WHEREAS, by Ordinance 4029, dated September 15, 2008, the Jackson County Legislature authorized an increase of \$23,000.00, on the same payment terms, at a revised total cost to the County not to exceed \$63,000.00.

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and **Organization** respectively agree as follows:

- Except as herein specifically modified or amended, all of the terms and conditions of the Original Agreement, shall remain in full force and effect.
- 2. The County shall pay to Organization for its services during the 2008 calendar year, an additional sum of \$23,000.00, at a revised total cost to the County of \$63,000.00, to be billed and paid as provided in the Agreement.
 - 3. The Addendum shall be effective upon its execution and extend, together



with the Agreement, dated June 12, 2008, until December 31, 2008.

4. This Addendum, together with the Agreement dated June 12, 2008, incorporates the entire agreement and understanding of the parties.
