ORDINANCE NO. 6043, November 17, 2025

INTRODUCED BY Venessa Huskey, County Legislator

WHEREAS, the Director of Finance and Purchasing has solicited bids on Request for Proposals (RFP) No. 25-027 for the furnishing of recruitment services for use by the Sheriff's Office, Detention Center, with a total annual estimated usage of \$102,600.00; and,

WHEREAS, a total of sixteen (16) notifications were distributed, and five (5) responses were received and evaluated with Changing Technologies, Inc. of Washington, DC awarded the contact; and,

WHEREAS, an evaluation committee reviewed the proposals submitted on the basis of qualifications, experience, references, and pricing and recommends the award of a contract to Changing Technologies, Inc. of Washington, DC; and,

WHEREAS, the Director of Finance and Purchasing recommends the award of a twelve-month contract, with two twelve-month options to extend, to Changing Technologies, Inc. under the terms and conditions of RFP No. 25-027, for the reason that it has submitted the best proposal; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER ORDAINED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contract and any subsequent extensions.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
