BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County

Counselor be and hereby is authorized to settle the claims of Nathan Parks in the lawsuit styled Nathan Parks v. Ford Motor Company, et al., Case No. 0816-CV00669, by the total payment of \$27,500.00, in full, final and complete release of all of the claims against the County and all of its employees, officers, agents and servants as to any damages incurred; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to issue checks in an amount totaling \$27,500.00, in full and complete settlement of this claim, pursuant to the specific direction of the County Counselor.
