USER AGREEMENT

THIS AGREEMENT is made and entered into this 4 day of August, 2010, by and between the **BOARD OF POLICE COMMISSIONERS OF KANSAS CITY, MISSOURI**, hereinafter referred to as "the Board," and **JACKSON COUNTY, MISSOURI**, hereinafter referred to as "the County."

WHEREAS, by Resolution 17305, dated June 14, 2010, the Jackson County Legislature did authorize the County to enter into a user agreement with the Board, in connection with the Kansas City, Missouri Police Department ALERT II System, for use by the County's Sheriff's Office, Department of Corrections, and Prosecuting Attorney's Office; and,

NOW THEREFORE, it is agreed by and between the parties as follows:

1. The Board shall grant certain privileges in connection with the Kansas City, Missouri Police Department ALERT II System to the County, for use by the County's Sheriff's Office, Prosecuting Attorney's Office, and Department of Corrections.
2. The County shall pay for the provided services in accordance with the fee schedule, attached hereto and incorporated herein by reference as Exhibit A. All charges for services shall be determined based upon the fee schedule.
3. This Agreement shall commence on July 1, 2010, and shall terminate on June 30, 2011, unless sooner terminated. The Board may terminate this Agreement by giving thirty days written notice to the County. The County may terminate this Agreement by giving thirty days written notice to the Board. Termination of this Agreement shall not


constitute a waiver of the rights or obligations which the County or Board may be entitled to receive or be obligated to perform under this Agreement. Should this Agreement terminate, all papers, documents, books and all other County materials must be destroyed or delivered and returned by Board to the County within 30 days of the demand of the County.

4. If any covenant or other provision of this Agreement is invalid, or incapable of being enforced, by reason of any rule of law or public policy, all other conditions and provisions of this Agreement shall nevertheless remain in full force and effect and no covenant or provision shall be deemed dependent upon any other covenant or provision unless so expressed herein.


5. This Agreement, together with the attached Exhibit A, incorporates the entire understanding and agreement of the parties.





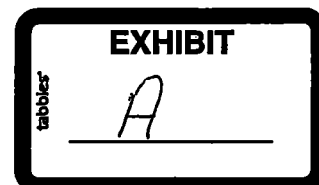
