#### 4 HEARINGS

Gary Eastman, Attorney for the Pension Board, was present to answer questions regarding Section 1542 - Plan Administrator Duties. The County Legislature adopted Ordinances #3799 and #3788 enacting sections 1523 and 1542 of the Jackson County Code, 1984.

Ed Rucker, County Counselor, said he will report back to the Legislature regarding this matter in two weeks.

Bob Spence, County Legislator, announced that Tom Reiss with Governor Blunt's office advised him that the Governor appointed Deron Cherry to the Jackson County Sports Complex Authority.

Henry C. Rizzo said he did not ask the County Counselor to place Resolution #16033 on the agenda. He asked the County Counselor to call him in the future before placing his name on controversial legislation.

Ed Rucker said Henry did not ask to sponsor Resolution #16033. He said it was a mistake made by his office, but they wanted to get the matter before the County Legislature.

#### 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, gave an update on the health and dental plans. The medical plan was bid out last year and we received several very competitive proposals. The Coventry health plan was ultimately selected. Although rates have increased approximately 14.5% over a two year period, they are still well below local and national averages.

The Dental Plan was also bid out last year and was awarded to Assurant Employee Benefits. The rate history on that plan has been very stable, with our last increase of 3% in 2005.

Pat O'Byrne with CBIZ and Jeff McDaniel with McDaniel/Hazley Group, the health insurance brokers and Bill Engelhoff, the dental broker, were present to answer any questions.

Katheryn Shields said she would like a Resolution directing her what to do regarding the medical and dental insurance plans.
