A RESOLUTION authorizing the Trustees of the Land Trust of Jackson County to convey three parcels of real property located in Kansas City, Missouri, to Palestine Neighborhood Development Corporation of Kansas City, MO, for the rehabilitation and redevelopment of the urban core in accordance with section 141.750.2, RSMo 2000.

RESOLUTION #17591, May 10, 2011

INTRODUCED BY Scott Burnett, County Legislator

WHEREAS, section 141.750.2, RSMo 2000, authorizes the Trustees of the Land Trust of Jackson County to convey title in fee simple for consideration less than two-thirds of the appraised value of a property, only after the consent of at least two of the Trustees' appointing authorities; and,

WHEREAS, the City of Kansas City, Missouri, by its Resolution 110072, approved February 10, 2011, has delegated the authority to its Director of Neighborhood and Community Services Department to approve the transfer of blighted properties held by Land Trust of Jackson County to neighborhood-based non-profit corporations for rehabilitation; and,

WHEREAS, by Resolution 17509, dated February 14, 2011, the Legislature did express its support for these efforts of the City Council and staff of the City of Kansas City to reduce blight in the city's urban core; and,

WHEREAS, the City of Kansas City, Missouri Director Neighborhood and Community

Services Department has recommended that the properties located at 3335 College Avenue, 3337 College Avenue, and 3438 Indiana, all located in Kansas City, MO, legally described in the attached Exhibit A, be conveyed to Palestine Neighborhood Development Corporation of Kansas City (Jackson County), MO, a Missouri non-profit corporation, to cultivate into a community garden and outdoor classroom in an effort to curb blight within the urban core; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Land Trust Trustees be allowed to convey the property listed on Exhibit A, for an amount of less than two-thirds market value, to Palestine Neighborhood Development Corporation, a Missouri non-profit corporation, for the purpose of better maintaining this property and revitalizing the area in which it is located; and,

BE IT FURTHER RESOLVED that the County Legislature of Jackson County, Missouri, encourages the Land Trust Trustees to include and enforce reversionary clauses in the conveyances regarding redevelopment of the properties within a prescribed time frame; and,

BE IT FURTHER RESOLVED that Land Trust Trustees are hereby authorized to execute any and all necessary documents to convey the above-described property for less than two-thirds market value.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.

Dear County Executive Sanders:

On behalf of Palestine Neighborhood Development Corporation, a Missouri non-profit corporation ("PNDC"), we are requesting that the Jackson County Legislature adopt a resolution authorizing the Land Trust of Jackson County ("Land Trust") to donate to such non-profit certain property located at:

3335 College Avenue, legally described as: South 19' of Lot 40 and North 11' of Lot 41

3337 College Avenue, legally described as: South 24 'of Lot 41 and North 6' of Lot 42

3438 Indiana, legally described as: North 11.48 'of Lot 66 and South 21.52' of Lot 67

All within Brougham Park, a subdivision in Kansas City, Jackson County, Missouri, according to the recorded plat thereof (the "Property").

PNDC is requesting the donation of two vacant Land Trust lots on College Avenue for the purposes of a community garden and outdoor classroom. PNDC acquired a structure at 3326 Indiana to develop as a Learning Center. That Center is in the block south of Central High School and is intended to be an outreach center for students. The renovation of that structure is nearly complete. Earlier this year PNDC purchased from the Land Trust an abutting lot at 3328 Indiana for the purpose of providing additional parking for the Learning Center. That acquisition was through the process outlined in the Missouri statutes for an abutting owner to acquire a vacant lot less than 4,000 square feet at one-half of the assessed value. That process was the most expeditious way to secure the parking. The most northerly of the two

lots on College Avenue sought to be donated adjoins on its eastern boundary the vacant lot on Indiana acquired for purposes of parking.

We are seeking a donation, rather than a purchase, of these lots because:

- Each of these properties on College Avenue contains 4,071 square feet, just over the statutory threshold for the discounted purchase, so that is not an avenue for PNDC. The assessed valuation for each of these lots is \$242 [below the statutory threshold of \$250], and but for these additional 71 square feet, PNDC could have purchased these lots for \$121 each.
- The preparation of the College Avenue lots for raised garden beds and the outdoor classroom will be a substantial expense for our non-profit organization, not all of which is being provided by those identified in our materials submitted to you, which is an additional reason for the donation.
- Specifically, providing a water source has been estimated to be an expense of about \$3,000 as to the College Avenue location [a single connection and meter] and a separate \$3,000 for the location on Indiana Avenue
- The property at 3438 Indiana Avenue has been cared for and utilized by this organization for over 15 years as a community garden and an outreach activities to the neighborhood, and this organization's past investment monetarily and with sweat equity on such lot has minimized the costs that would have otherwise been occurred for an abandoned vacant lot low to the Land Trust, and the City.

The re-direction of the two College Avenue vacant lots to a beneficial use, and the solidification of the ownership into PNDC, as an abutting owner, and will enable better maintenance to occur and strengthen this immediate neighborhood. The Learning Center and the community gardens and an outdoor classroom will serve as an anchor for this neighborhood.

Please favorably consider our request for the donation of the Property from the Land Trust.

Through Urban Green Dreams resident leaders provide instruction to students in schools utilizing the MU Extension curriculum "Eating From the Garden," which takes students from growing to preparing meals. The 33rd & College site will be a part of PNDC's new Mable Washington Learning Center at 3326 Indiana. The center was established thanks to a Community Development Block Grant from the City of Kansas City to convert a vacant blighted property into a community learning center for workforce and youth literacy along with employment training. This garden will be developed in conjunction with Metropolitan Missionary Baptist Church's Heart of America Boy Scouts Troop 56. Eagle Scout candidate Julian Marshall will work alongside PNDC's Master Gardener/Master Naturalist Dr. Barbara Johnson to conduct site layout and design as wells as resource development.

The 33rd & College Community Garden will serve as yet another wonderful example of what can take place when concerned residents and governmental agencies work together to create something wonderful for the community.
