

**FIRST ADDENDUM TO
COOPERATIVE AGREEMENT**

THIS FIRST ADDENDUM made this 22nd day of July, 2013, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "County" and **KANSAS CITY SPORTS COMMISSION AND FOUNDATION**, 114 West 11th Street, Kansas City, Missouri 64105, hereinafter referred to as "Sports Commission."

WITNESSETH:

WHEREAS, Sports Commission and County entered into a Cooperative Agreement dated April 16, 2013, whereunder Sports Commission agreed to provide the Buck O'Neil Negro Leagues Baseball Clinic and Tournament, as authorized by Resolution 18055, dated January 7, 2013, at a cost to the County not to exceed \$3,500.00; and,

WHEREAS, it is necessary to revise the original budget presented by Sports Commission by reallocating \$3,500.00 from umpire fees and field maintenance to marketing and clinicians to support two baseball clinics in lieu of a tournament, as is more fully described in the Section C: 2013 Revised Program Budget page attached hereto as Exhibit A and incorporated herein by reference; and,


WHEREAS, the execution of this addendum is authorized by Resolution 18204, dated July 1, 2013;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Sports Commission respectively agree with each other as follows:




1. Except as expressly provided herein, all provisions of the Cooperative Agreement between Sports Commission and County, dated April 16, 2013, shall remain in full force and effect.
2. The Cooperative Agreement of April 16, 2013, is amended by the substitution of Exhibit A attached hereto, for Section C: 2013 Program Budget page in the Exhibit A attached to the Cooperative Agreement.
3. This First Addendum to the Agreement, together with the Cooperative Agreement, dated April 16, 2013, shall be effective January 1, 2013 and shall extend until December 31, 2013.
4. This First Addendum to Agreement, together with the Cooperative Agreement dated April 16, 2013, incorporates the entire understanding and agreement of the parties.


