## FIRST ADDENDUM TO COOPERATIVE AGREEMENT

THIS FIRST ADDENDUM made this 22nd day of Sully 2013, by and between JACKSON COUNTY, MISSOURI, hereinafter called "County" and KANSAS CITY SPORTS COMMISSION AND FOUNDATION, 114 West 11<sup>th</sup> Street, Kansas City, Missouri 64105, hereinafter referred to as "Sports Commission."

WHEREAS, the execution of this addendum is authorized by Resolution 18204, dated July 1, 2013;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Sports Commission respectively agree with each other as follows:

- 3. This First Addendum to the Agreement, together with the Cooperative Agreement, dated April 16, 2013, shall be effective January 1, 2013 and shall extend until December 31, 2013.
- 4. This First Addendum to Agreement, together with the Cooperative Agreement dated April 16, 2013, incorporates the entire understanding and agreement of the parties.
