WHEREAS, the Sheriff's Office recommends an agreement with the Metropolitan Community College – Blue River Police Academy to provide Peace Officer Standards and Training (POST) in-service training for the Sheriff's Office to meet POST certification requirements, at a cost to the County not to exceed \$20,475.00; and,

WHEREAS, this agreement is in the best interest of the health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Agreement with the Metropolitan Community College; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the Agreement.
