BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Execute be and hereby is authorized to execute the attached Memorandum of Understanding with the Eastern Jackson County Development Alliance; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to issue a payment to the Eastern Jackson County Development Alliance, to the extent sufficient appropriations to the using spending agencies have been made in the then current Jackson County budget.

Memorandum of Understanding ("MOU") between Jackson County, Missouri and the Eastern Jackson County Development Alliance

- 1. This MOU is intended to represent the relationship between Jackson County, Missouri ("Jackson County") and the Eastern Jackson County Development Alliance ("EJCDA"), a Missouri nonprofit and 501(c)(6) entity. Jackson County and the EJCDA, collectively, are "the parties".
- 2. Jackson County is a Founding Member of the EJCDA.
- 3. Other Founding Members of the EJCDA include: the City of Grandview, City of Lee's Summit, City of Raytown, City of Independence, City of Blue Springs, City of Grain Valley and City of Oak Grove.
- 4. Founding Members may assess dues against the Founding Membership in terms deemed necessary by the Board of Directors.
- 5. The parties agree to reevaluate dues on an annual basis. Jackson County shall owe no additional funds to the EJCDA and shall not be responsible for any additional duties to the EJCDA other than contributing the dues agreed to on an annual basis.
- 6. This MOU may be terminated by Jackson County by giving thirty (30) days written notice to the EJCDA. The written notice shall be provided to the EJCDA at 201 N. Forest Avenue, #120 Independence, MO 64050.
- 7. All other aspects of the relationship between Jackson County and the EJCDA shall be governed by the EJCDA's Articles of Incorporation and by-laws.
