WHEREAS, the Sheriff's Office has been awarded a grant in the amount of \$5,000.00 by the Missouri Highways and Transportation Commission, to increase efforts to reduce aggressive driving and alcohol-related crashes; and,

WHEREAS, the grant will enable the Jackson County Sheriff's Traffic Unit to increase enforcement efforts related to various violations, including but not limited to careless and imprudent driving, following too close, and speeding; and,

WHEREAS, the grant term is July 1, 2013, through May 1, 2014, and the grant does not require a local match; and,

WHEREAS, the Sheriff recommends the acceptance of this grant and the execution of a contract with the Missouri Highways and Transportation Commission; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation from the fund balance of the 2013 Grant Fund be and hereby is made:
