

**IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI**

**An ORDINANCE** appropriating \$500.00 from the unappropriated surplus of the 2007 Grant Fund and authorizing the Director of the Department of Finance and Purchasing to issue a check in the amount of \$500.00 to the Little Blue River Watershed Coalition for co-sponsorship of the Missouri River Watershed Festival.

**ORDINANCE # 3951**, November 13, 2007

WHEREAS, on October 5, 2007, at Kaw Point in Kansas City, KS, the Little Blue River Watershed Coalition and the Missouri River Watershed Festival Committee hosted "The Missouri River Watershed Festival," a family event designed to educate Kansas City region elected officials, government management, stormwater professionals, consultants, and their families in the importance of conserving the Missouri River Watershed; and,

WHEREAS, Jackson County was advertised as a co-sponsor of this event; and

WHEREAS, the sponsorship of this event, at a cost to the County not to exceed \$500.00, is in the best interest of the health, safety, and welfare of the citizens of Jackson County, Missouri; and

WHEREAS, this sum is available out of grant funds received by the Storm Water Commission from local municipalities; now therefore

BE IT ORDAINED by the County Legislature of Jackson County, Missouri that the following appropriation from the unappropriated surplus of the 2007 Grant Fund be and hereby made:
