TITLE: A resolution transferring \$182,000 from the 3% Contingent Appropriation account in the General Fund for the purpose of the emergency repair of two road culverts in unincorporated Jackson County and to demolish the old Health Department buildings in Independence, Missouri using existing County term and supply vendors

SUMMARY: This resolution requests the transfer of \$182,000 from the Contingent Appropriation of the General Fund to two different accounts in the General Fund to address emergency and public safety issues on Jackson County property. \$125,000 is requested to be transferred to provide emergency funding to demolish the old Jackson County Health Department located at 313 S Liberty St. in Independence, Missouri. The building has been vacant since 2023 and has recently been the subject of vandalism resulting in significant property damage to the structure. Demolition of the structures will ensure that further vandalism does not occur. Demolition costs plus any required environmental remediation are estimated at \$125,000 with all work being performed by current County term and supply vendors. In addition, a total of \$57,000 is requested to buy two replacement

culverts that were washed out after the recent storms. Portions of Jim Owens Road and Cummings Road in unincorporated Jackson County are currently closed until these repairs can be made. Installation of the culverts will be performed by County road crews and the replacement culverts will be purchased from current County term and supply vendors.
