AN ORDINANCE awarding a contract for construction service to connect the Rock Island Trail and Little Blue Trace Trail under Federal Project No. TAP 3453(404) to MegaKC Corporation Kansas City, MO, under the terms and conditions of Invitation to Bid No. 24-098 at a cost to the County not to exceed \$2,870,540.00.

ORDINANCE NO. 6004, August 4, 2025

INTRODUCED BY Manuel Abarca IV, County Legislator

WHEREAS, Parks + Rec Department has a priority to connect the Rock Island Trail and Little Blue Trace Trail; and,

WHEREAS, the construction of a 10-foot-wide concrete non-motorized transportation facility with improvements to include concrete pavement, micro surfacing, pavement repair, signing, striping erosion control, fencing, storm drainage, grading, slope stabilization, and rock base support will be needed to establish the trail; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 24-098 for the construction of this project; and,

WHEREAS, a total of two (2) responses were received and evaluated from the following:

MegaKC Corporation Kansas City, MO	\$2,870,539.50
Radmacher Brothers Excavating, Inc. Pleasant Hill, MO	\$5,661,180.45

and,

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Directors of Finance and Purchasing and Parks + Rec recommend award for the construction of bridge improvements to MegaKC Corporation Kansas City, MO, for the reason that it has submitted the lowest and best bid; and,

WHEREAS, in the event that line item adjustments to the contract become necessary, it is appropriate that the Director of Parks + Rec be authorized to approve said line item adjustments, to the extent there is no additional cost to the County; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Parks + Rec, and that the County Executive be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award, in forms to be approved by the County Counselor; and,

BE IT FURTHER ORDAINED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contract.

Effective Date: This ordinance shall be effective immediately upon its signature by the County Executive.
