A Resolution authorizing the County Executive to execute Cooperative Agreements with Swope Health to provide public health-related and other public services to citizens of Jackson County, at an aggregate cost to the County not to exceed \$163,000.00.

Authorizing the transfer \$163,000 from the Health Levy fund.

Request Summary

Request for legislative action to authorize the County Executive to execute Cooperative Agreements with Swope Health from allocated funding by the Legislature with the adoption of Ordinance 5701 for the 2023 Budget. Swope Health submitted an application requesting funding through the outside agency portal by the March 31, 2023 deadline with the required documents properly submitted and vetted in the application process. The application process was posted on the county's website and open for 35 days. This agency has met the county's liability insurance requirement and has obtained a tax clearance for taxes due/exempted December 31, 2022. Notification will be sent to the County Counselor's Office to begin drafting the 2023 contracts. Attached document lists the 3 outside agency proposed programs totaling \$163,000 allocated funding by the Legislature with the adoption of the 2023 Budget.

WHEREAS, in 2020 32 agencies and 39 programs were funded; and, WHEREAS, in 2021 33 agencies and 40 programs were funded; and, WHEREAS, in 2022 38 agencies and 44 programs were funded; and, WHEREAS, in 2023 60 agencies and 67 programs will be funded; and,

WHEREAS, The following criteria was created and applied to all agencies to determine award; and,

- 1. Maximum award of \$40,000; Minimum award of \$20,000 on New Requests
- 2. 64% Direct Expense -To equal 2023 Outside Agency Budget
- 3. 58% Indirect Expense -To equal 2023 Outside Agency Budget
- 4. Reduction of 2022 funds left unspent
- 5. Reduction of any requested salary expense over 50%
- 6. Awards have been rounded to equal 2023 Outside Agency Budget
- 7. Reductions were not applied to 3 agencies requesting under \$10,000*
