Although the major emphasis was eminent domain at MoDot, all staff attorneys represented their employer in matters including, but not limited to, workers' compensation, tort litigation and contract disputes. We also worked with the right-of-way department in anticipation of acquiring needed real estate upon which to build or widen highways required title opinions. Thus prescriptive easements, abandoned railroad rights of way, cemeteries, utility easements, environmental issues and other potential clouds on title made a day interesting.

I mention this experience as it appears prudent and timely for the Truman Sports Complex to search for higher and better uses of its real estate assets and adjoining properties.

Representing the MoDot Permits Department also gave an occasional break from the courtroom. All too often abutting landowners would "break" access to our roadway without applying for a permit. I recall warning a property owner

to cease and desist or we would physically remove his illegally placed culvert from our right of way. Ignoring our repeated demands, we arrived at the site with a road grader. The landowner arrived with a shotgun. I left and returned with the Highway Patrol.

I mention this as a simple example of judiciousness over emotional response.

He graduated from Rockhurst College in 1978, summa cum laude, with degrees in history and political science. He earned his juris doctorate degree from UMKC Law School in 1981. He has been a practicing attorney for nearly forty-two years and is a Charter Member of the law firm of Monaco, Sanders, Racine, Powell & Reidy, L.C. As an attorney, Mr. Monaco has served as an adjunct professor at UMKC Law School, received the 2022 Preeminent AV Peer Review Award—the pinnacle of professional excellence from Martindale Hubbell, named Phi Alpha Delta (PAD) law fraternity's Alumni Member of the Year, where an annual award was established known as the "the Ralph A. Monaco Outstanding 3L Student Award" and produced numerous historic retrials in collaboration with UMKC Law School and the Jackson County Historical Society ("JCHS"),

Mr. Monaco has a long-standing record of public and community service. He taught at the Parish School of Religion at Our Lady Lourdes Catholic Church for nearly a decade. He formerly served on the Jackson County Jail Task Force, the Storm Water/Park Board Tax Committee for the City of Raytown, the Board of Directors of Elmwood Cemetery in Kansas City, the Board of Directors of the Rice-Tremonti House in Raytown, and as a Board Member of the Three Trials Museum in Independence.
