

**FIRST ADDENDUM TO
COOPERATIVE AGREEMENT**

THIS FIRST ADDENDUM made this 6th day of September, 2013, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "County" and **W.E.B. DUBOIS LEARNING CENTER**, 6409 Agnes, Avenue, Kansas City, Missouri 64132, hereinafter called "Agency."

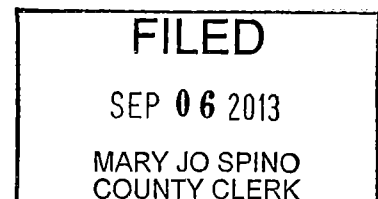
WITNESSETH:

WHEREAS, Agency and County entered into a Cooperative Agreement dated February 15, 2013, whereunder Agency agreed to provide a tutorial program, as authorized by Resolution 18053, dated January 7, 2013, at a cost to the County not to exceed \$40,000.00; and,

WHEREAS, it is necessary to revise the original budget presented by Agency due to staffing changes, as is more fully described in the Section C: 2013 Revised Program Budget page attached hereto as Exhibit A and incorporated herein by reference; and,


WHEREAS, the execution of this addendum is authorized by Resolution 18228, dated July 29, 2013;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Agency respectively agree with each other as follows:




1. Except as expressly provided herein, all provisions of the Cooperative Agreement between Agency and County, dated February 15, 2013, shall remain in full force and effect.

3. This First Addendum to the Agreement, together with the Cooperative Agreement, dated February 15, 2013, shall be effective January 1, 2013 and shall extend until December 31, 2013.
4. This First Addendum to Agreement, together with the Cooperative Agreement dated February 15, 2013, incorporates the entire understanding and agreement of the parties.


