FIRST ADDENDUM TO AGREEMENT

THIS FIRST ADDENDUM made and entered into this 21st day of June, 2010, by and between Jackson County, Missouri, a Constitutional Home Rule Charter County of the State of Missouri, hereinafter referred to as "the County," and Cave Spring Association, Inc. 8701 E. Gregory, Kansas City, MO 64133, hereinafter called "Cave Spring."

WITNESSETH:

WHEREAS, by Resolution 17139, dated January 19, 2010, the Jackson County Legislature, authorized an agreement with the Cave Springs Association in the amount of \$22,277.00 to be used for contractual services and liability insurance; and,

WHEREAS, by Resolution 17292, dated May 24, 2010, the County Legislature did authorize a revised budget presented by Cave Springs Association; and,

WHEREAS, the parties now desire to amend the said Agreement, on the same terms, at no increased cost to the County as more fully set out in the proposal attached hereto and incorporated herein by reference as Exhibit A; now therefore,

IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. Except as expressly provided herein, the original Agreement between the parties shall remain in full force and effect.
2. This Addendum shall be effective upon its execution and extend, together with the original contract as proposed by Resolution 17139 until December 31, 2010.
3. This Addendum together with the Agreement authorized by Resolution 17139 constitutes the entire Agreement and understanding of the parties.



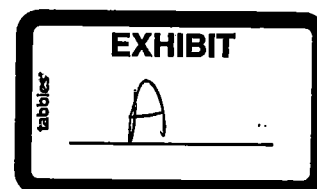
