IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

- 1. Except as expressly provided herein, the original Agreement between the parties shall remain in full force and effect.
- 2. This Addendum shall be effective upon its execution and extend, together with the original contract as proposed by Resolution 17139 until December 31, 2010.
- 3. This Addendum together with the Agreement authorized by Resolution 17139 constitutes the entire Agreement and understanding of the parties.




