BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is authorized to issue a check or checks in an amount totaling \$40,000.00 in full and complete settlement of this claim, payable to Mary L. Schlueter and/or her attorney, Mark Kelly, pursuant to the specific direction of the County Counselor.
