TITLE: Awarding an eleven (11) month term and supply contract with four (4) twelve (12) month options to extend, for the furnishing of Prisoner Transport Services for Jackson County Sheriff's Office Detention Center to Security Transport Services, Inc, of Topeka, Kansas, under the terms and conditions of Johnson County, KS Contract No. 2026-014, an existing competitively bid contract.

SUMMARY: Jackson County Sheriff's Office Detention Center has a continuing need for the furnishing of Prisoner Transport Services to facilitate the transportation of fugitives apprehended outside the State of Missouri on original Jackson County warrants and the transportation of persons committed to the custody of Jackson County Sheriff's Office. The fully executed services agreement, contractors bid response and the using department disposition memo are attached. Pursuant to Section 1030.4 of the Jackson County Code, the Jackson County Sheriff's Office Detention Center and the Director of Finance & Purchasing Department recommends the award of an eleven (11) month term and supply contract with four (4) twelve month options to extend for the furnishing of Prisoner Transport Services for use by Sheriff's Office to Security Transport Services, Inc, of Topeka, Kansas, under the terms and conditions of Johnson County, KS Contract No. 2026-014, an existing competitively bid contract. As per the contract documents Cooperative Procurement with Other Jurisdictions, Security Transport Services, Inc, agrees to extend the contracts pricing and terms to any municipal entity, County, Public entity, hospital, educational institution or other non-profit organizations. This award is made on as "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The annual estimated spend is \$252,700.00. The Jackson County Compliance portal was checked, and the vendor has Status of "Certificate Issued and Emailed to Vendor"
