The Department of Corrections: Support Services has reviewed the bid recap for 64-20: Inmate Clothing.

It is recommended that the bid be split between the vendors due to the items cost and the quality. The following evaluation lists the average cost for the item and provides the recommendation for award. It is estimated that the Department of Corrections will spend \$80,000 on inmate clothing in 2021.

Splitting the contract between three vendors will help to ensure that we are able to keep a sufficient stock of clothing. Providing good quality, competitively priced clothing to the inmate population is essential to the operation.

- 5.3 Contractor Utilization Plan, pages 22 through 26, hereof must be filled out, signed, notarized, and submitted with your bid. Failure to include this document with your bid may **RESULT IN THE REJECTION OF YOUR BID.**
- 5.4 Failure to include any of the items listed above may result in the **REJECTION** of your bid.

**6.0 EVALUATION PROCESS**

- 6.1 All bids received that are responsive to the General Conditions, Specifications, and other provisions of this Invitation to Bid will be evaluated. An Evaluation Committee made up of Jackson County, Missouri personnel will evaluate bids and make recommendations. Jackson County, Missouri shall be the sole judge of the bids submitted and its decision shall be final.

- 7.2 Respondents and their agents (including subcontractors, employees, consultants, or anyone else acting on their behalf) must follow this procedure. Respondents or their agents may not contact any other County personnel regarding the matters covered by this Invitation to Bid during the solicitation and evaluation process. Inappropriate contact is grounds for **REJECTION** of Respondent's bid.


