O8-22 Pursuant to section 706.1, Jackson County Code, 1984, I hereby promulgate the attached "Ethics Code for Jackson County Employees," which will supplement the County's Personnel Rules.

Dennis Waits asked the County Counselor's office to prepare an Ordinance for the County Legislature's approval next week regarding Executive Order #08-22. He asked all County Legislators to review the document and make any changes.

After checking, Jay Haden, Deputy County Counselor, advised Dennis Waits that the Legislature could have a public hearing regarding the 2009 budget on Monday, November 24, 2008.

Dennis Waits said after budget hearings on Thursday, Legislators should get any amendments to Henry Rizzo, Chairman of the Budget Committee, so they could be prepared and included with the budget amendment.

Jay Haden explained that the Legislature does not need to pass the budget at the same meeting as the public hearing.
