AMENDMENT #6

TO COMPONENT SERVICES AGREEMENT 4.3 - OWNER'S REPRESENTATIVE DESIGN and CONSTRUCTION SERVICES — SCOPE (Project Timeline Extension)

Jackson County, a public body corporate and politic of the State of Missouri, and JCDC Partners, LLC (JCDC), a Missouri limited liability company (Consultant) entered into an Owner's Representative Service Agreement on May 27, 2022, for the provision of specified professional services related to Jackson County project number 40468 ("Project"). This Amendment #6 is effective November 3, 2025 and provides a ninemonth time extension and related compensation to the original Payment Schedule defined in Article 2.2 of the Component Services Agreement. This Amendment coordinates with the current Detention Center construction project schedule concluding with Final Completion on February 12, 2026.

SERVICES

Specific Owner's Representative tasks related to the project timeline extension through February 28, 2026 remain in accordance with Article 1 of the Component Services Agreement 4.3.

COMPENSATION

The fee for this additional time and scope will be a lump sum of \$282,853.84 as summarized below.

The current agreement amount, including reimbursable expenses, is \$8,808,695. Increasing the Fee for CSA 4.3 by \$282,853.84 results in a new total agreement amount of \$9,091,548.84. This request does not change the schedule or cost for CSA 5.0, which concludes six months after Substantial Completion.

Invoices will be submitted retroactively for the dates specified above.

OTHER CONDITIONS

All terms and conditions of the Consultant Agreement shall remain in full force and effect.
