AN ORDINANCE appropriating \$2,000.00 from the undesignated fund balance of the 2013 Persistent Driving While Intoxicated Offender Fund.

ORDINANCE NO. 4510, February 25, 2013

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, pursuant to section 571., Jackson County Code, 1984, the Persistent Driving While Intoxicated (DWI) Offender Fund was established to receive payments from defendants prosecuted as persistent DWI offenders; and,

WHEREAS, pursuant to section 571.3, Jackson County Code, the Prosecuting Attorney recommends that funds in the amount of \$2,000.00 be appropriated to provide for staff salaries with the Prosecuting Attorney's Office to defray the cost of DWI prosecution; and,

WHEREAS, an appropriation is necessary to place the necessary funds in the appropriate spending accounts; now therefore,

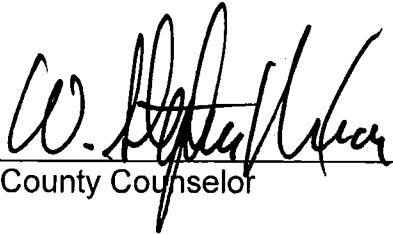

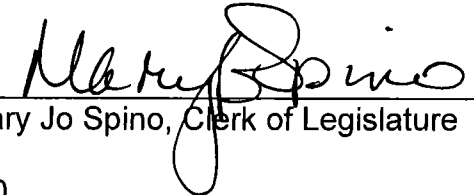
