AN ORDINANCE appropriating \$15,000.00 from the undesignated fund balance of the 2017 Anti-Drug Sales Tax Fund and authorizing the County Executive to execute an agreement in acceptance of funding provided by the Organized Crime Drug Enforcement Task Force for use by the Jackson County Drug Task Force for "Operation Squeaky Banjo."

ORDINANCE NO. 4959, February 27, 2017

INTRODUCED BY Dan Tarwater III, County Legislator

WHEREAS, by Ordinance 4865, dated July 18, 2016, the Legislature authorized the acceptance of a grant provided by the Organized Crime Drug Enforcement Task Force (OCDETF) to conduct a joint federal drug investigation in conjunction with the Jackson County Drug Task Force, OCDETF Case No. WC-MOW-306, Operation Squeaky Banjo, for the period of October 1, 2015, through September 30, 2016; and,

WHEREAS, by Ordinance 4921, dated October 31, 2016, and Ordinance 4934, dated November 21, 2016, the Legislature did authorize the appropriation of additional funding received from the OCDETF toward this operation; and,

WHEREAS, the OCDETF has authorized additional funding for the reimbursement of overtime related to this operation, in the amount of \$15,000.00; and,

WHEREAS, an appropriation is necessary to place the additional funds in the proper spending account; now therefore,




