My last three years of service were spent as the Chief Warrant Officer and Trial Team Leader for the Kansas City Warrant Desk, a position I was promoted to by James Kanatzar. My duties included supervising a diverse team comprised of four attorneys, legal interns, an investigator, a victim advocate and support staff. I managed diversion programs and dockets for the Warrant Desk while directing a trial team. I was directly responsible for overseeing the day to day intake and review of nearly all general crimes from the Kansas City, Missouri Police Department and other law enforcement agencies. This position allowed me daily interaction with the court, the police and members of the community. I also was responsible for serving on an operations committee with members of the judiciary, court personnel, members of the defense bar, law enforcement and jail personnel.

Throughout my fourteen years as an Assistant Prosecuting Attorney, I held the following positions within the Jackson County Prosecutor's office, holding nearly every assignment within the office under the leadership of multiple Prosecuting Attorneys:

- Sex Crimes and Child Abuse Unit My work in this unit was the most rewarding and the most difficult position held during my tenure. I prosecuted complex cases in both Kansas City and Independence working to achieve justice for victims. My work in this unit included the evaluation and filing of charges against serial rapists, cold-hit DNA rape cases, child homicides and cases involving sexual abuse against children.
- **Domestic Violence Unit** This was a challenging but rewarding part of my service at the prosecutor's office. I successfully tried multiple cases and achieved the goal of raising public awareness of domestic violence and its terrible effects on its victims, including children.
- Grand Jury Prosecutor The position of Grand Jury Prosecutor gave me a broad view of crime and its impact on every corner of Jackson County. In this position, I developed relationships with nearly every local, state and federal law enforcement agency within the jurisdiction.
- Warrant Desk Attorney In this position, I handled approximately 80 preliminary hearings in cases ranging from Robbery in the First Degree to Tampering with a Motor Vehicle. This position allowed me to develop the ability to access evidence quickly, work with victims of crimes and negotiate appropriate outcomes.
- DART Unit As the coordinator, I lead the Drug Abatement Response Team (DART), supervising a team of professionals from multiple agencies and served as the community liaison for the Kansas City, Missouri Police Department to target drug houses and businesses for legal action. In this position, I was responsible for grant funding and all aspects of DART and cooperating agencies. Additionally, I spearheaded an effort to address rampant criminal activity in some area hotels. This effort included inspections of these hotels based on documented criminal activity on those properties and special training programs for hotel owners and managers
- Civil Forfeitures In this position, I developed a protocol, under supervision of then Prosecutor
 Robert Beaird, for filing and settlement disposition of civil cases involving seized personal
 property connected to illegal activity. I developed a working relationship with multiple law
 enforcement agencies at the federal and state level. I successfully tried civil forfeiture cases and
 conducted multiple default hearings.
- Drug Enforcement Unit/Drug Court During my service in the Drug Enforcement Unit, I tried
 multiple drug possession cases under the supervision of numerous great trial attorneys. In this
 position, I learned to how to effectively try a criminal case, but also to seek appropriate outcomes.
 I fully supported drug court programs in our community in an effort to prevent individuals from
 entering into our community with untreated drug addictions and felony convictions. I managed
 multiple dockets in drug court and found myself moved by those who conquered drug addiction
 through this program
- Family Support I began my service as an intern in the office of Child Support Enforcement. I tried my first case as an intern in this position in a first-chair capacity and my second case as an Assistant Prosecutor before transferring to the Drug Enforcement Unit.
- From 2007 to 2010, served on the Homicide Committee, and assisted in the review of all violent crimes from investigation to disposition of the case on a monthly basis.
- Tried over 60 jury trials in a first-chair capacity, primarily violent crimes.

Special accomplishments as a trial attorney:

- Worked with experts in the areas of child forensics, psychological evaluations, medicine, and linguistics.
- Worked on death penalty cases, including *State of Missouri v. Terry Blair* in a second-chair capacity, and provided research and advice on other death penalty cases within the office.
- Managed special assignments in the office including post-conviction cases and probation violations.

- Taught at the Kansas City, Missouri Police Academy in the areas of search and seizure, civil forfeiture and fraud to police officers.
- Provided training on preventing identity theft to a League of Women Voters forum in Independence, Missouri.
- Presented personal safety concerns as it relates sex crimes to UMKC students, and training for social workers and psychologist on evidentiary issues in filing a sex crimes case.
- Provided training programs through the Sue Shear Institute aimed at fostering leadership skills in college students.
