- 1. Except as expressly provided herein, all provisions of the Prior Agreement dated May 12, 2011, between Oppenheimer and County shall remain in full force and effect.
- 2. The maximum sum to be paid by County to Oppenheimer shall be increased by an amount not to exceed \$100,000.00, for a maximum total of \$300,000.00.
- 3. Oppenheimer shall submit periodic statements itemizing the charges to be paid by the County.
- 4. This First Addendum shall be effective as of January 1, 2012, and shall extend until December 31, 2012.
- 5. This First Addendum, together with the Agreement dated May 12, 2011, incorporates the entire understanding and agreement of the parties.
