**TITLE:** A RESOLUTION awarding a contract for an upgrade to the Granicus Operations Cloud - Governance (legislative) Suite with fully managed video and closed captioning services for use by the Office of the Clerk of the County Legislature to Granicus of St. Paul, MN, at a cost to the County not to exceed \$179,785.00, as a sole source purchase, subject to appropriation in the 2026 budget.

**SUMMARY:** The Office of the Clerk of the County Legislature currently uses Granicus Encoding, Open Platform Suite and Meeting Efficiency Suite for legislative meetings but is requesting an upgrade to the Governance (Legislative) edition of Operations Cloud which leverages a blend of strategic capabilities, data insights and technology built for government to deliver an experience aimed at enhancing user engagement and boosting operational efficiency for the Kansas City Legislative Assembly Area. The upgrade would include the closed captioning service moving to an automated transcription service in English and Spanish with text. The upgrade would also provide for a fully managed remote broadcast system for streaming video, including an upgrade from 720p to 1080 p Resolution. The annual software support and maintenance are included with this upgrade.
