REQUEST SUMMARY	There is a need to add courtrooms, and make major modifications to the Eastern Jackson County Courthouse. Burns and McDonnell Engineers was hired to create plans and specifications to do this work. The major improvements in the design are: A dding 5 courtrooms, one of the 5 is a combine jury room, municipal courtroom. A new stair structure to allow emergency egress out the west end An additional elevator on the north side located east of the existing elevator. A new enlarged entry on the south side at the location of the existing entry New heating, cooling, and ventilation units. Paint, carpet, lighting upgrades to the public areas. Improvements to vacated areas for support services The Department of Public Works solicited bids for this project. The bid was advertised in the Daily Record, and placed on the Public Purchase Web site. Sealed proposals were opened on July 29, 2014 at the offices of Public Works. Two (2) firms submitted bids. A summary of the two lowest bids are as follows: AS READ Contractors Name Bid Amount City & State Excel Constructors, Inc. \$6,874,560.00 Overland Park, KS. Barsto Construction, Inc. \$7,132,000.00 North Kansas City, MO. The low bid was higher than the budget. Staff meet with the Courts, and the low bidder to value engineer the project resulting in a reduction in the bid. The new low bid contract amount is \$6,486,011.00. Excel Constructors, Inc, the lowest bidder, has agreed to this reduction and the new contract amount. The value engineering didn't compromise any of the major improvements. The Public Works Department has reviewed the bids and recommends the project be awarded to Excel Constructors, Inc. as the lowest and best bidder. We further request that 1. An Ordinance be prepared authorizing the County Executive to execute a contract with Excel Constructors, Inc. in the amount of \$6,486,011. 2. The Director of Public Works be authorized to approve adjustments in the Construction Contract from a force account of the project established as a contingen
