SUMMARY: Various County Departments require a Term and Supply Contract for the furnishing of Tree Removal Services. The Purchasing Department issued Invitation to Bid No. 25-044 in response to those requirements in which a total of (850) notifications were distributed, there were (54) document tackers with (2) submission received and evaluated. One submission was eliminated as the Compliance Review Office determined the vender did not provide sufficient Good Faith Effort in meeting assigned compliance goals. The Bonfire Executive Summary, department recommendation memos and the recommended Bidders Quotation Sheet are attached. Pursuant to Section 1030.4 of the Jackson County Code, the Finance & Purchasing Department recommends the award of a Twenty-four (24) Month Term and Supply Contract with One (1) Twelve Month option to extend for the

This award is made on an "as needed" basis and does not obligate Jackson County, Missouri to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The County's annual estimated expenditure is \$215,000.00. The Jackson County Compliance portal was checked and the recommended vendor has Status of "Certificate Issued and Emailed to Vendor" certificate showing 12/31/2025 expiration date.
