the purchase of the Trailer and Skid Steer Loader to K.C. Bobcat of Blue Springs, MO under the terms and conditions of Sourcewell Contract No. 092922-MNR (Trailer), and Sourcewell Contract No. 020223-CEC (Skid Steer Loader) both existing competitively bid government contracts at an actual cost of \$76,101.41. The trailer will be used for multiple purposes, but most of all to transport the new Skid Steer Loader. Both pieces of equipment are vital to the operations of the Park Operations Division of the Parks + Rec Department as they maintain miles of trails each day. This purchase is accounted for in the Parks 2024 approved Capital Fleet Replacement budget. To fund the purchase, we are requesting a transfer of \$23,200.00 from fund 003-1010-58170 to fund 003-1010-58110 and transfer \$53,000 from 003-1010-58130 to 003-1010-58110.
