TITLE: Awarding an existing MARC/KCRPC contract for salt and deicer for use by the Public Works Department to Central Salt LLC and Hutchinson Salt; under the terms and conditions of Mid-American Regional Council Contract No. 112.

SUMMARY: A RESOLUTION awarding an existing MARC/KCRPC contract for salt and deicer for use by the Public Works Department to Central Salt LLC of Lyons, KS and Hutchinson Salt Co of Baxter, KS under the terms and conditions of Mid-America Regional Council Contract No. 112, an existing competitively bid contract. Whereas Hutchinson Salt shall be the main vendor for road salt and Central Salt will be the secondary vendor for road salt. Central Salt will be the primary vendor for deicer. This contract is effective from July 1, 2024 to June 30, 2026 with the option to renew in writing for three (3) one-year renewal periods. This award is made on an "as-needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The Public Works Department estimates it could spend approximately \$225,000 annually on these products. 1030.4 Fixed Price Contractual Documents.

Competitive bidding shall not be required when the items purchased are the subject of existing and current federal, state, or local government fixed price contractual documents, if the prices quoted in those documents are more advantageous to the County than local market prices for like items. Before a purchase is made pursuant to this subsection which has a purchase price in excess of twenty-five thousand dollars (\$25,000), the Director of Finance and Purchasing shall submit the purchase to the County Legislature for approval and the purchase shall only be effective upon legislative approval. In the recommendation to the Legislature, the director shall set out the reason for decision not to seek competitive bids. (Ord. 3839, Eff. 11/28/06)
