TITLE: Awarding a Twenty-Four (24) Month Term and Supply Contract with Two (2) Twelve Month options to extend for the furnishing of Law Enforcement Web Services for use by various County Departments to the Regional Justice Information Services (Rejis) of St. Louis MO, as an acquisition form another government entity. The contract term to begin 3/28/2026 after existing term expires 3/27/28.

SUMMARY: Jackson County, Missouri has annually entered into a Subscription Agreement with Rejis (Regional Justice Information Service) for Law Enforcement Web Services and other associated services to check background history, obtain criminal history and share information with other law enforcement agencies in the State of Missouri. Various County Departments require a Term and Supply Contract for the furnishing of Law Enforcement Web Services. The REJIS Commission is dedicated to providing innovative, secure information technology (IT) solutions by integrating criminal justice jurisdictions. Rejis provides the storage and manages the data for the public sector, that data is secured by the region's top experts in law enforcement, criminal justice, and technology. REJIS

provides secure access, storage, and management of critical data. Pursuant to Section 1030.4 of the Jackson County Code, the Purchasing Department recommends the award of a Twenty-Four (24) Month Term and Supply Contract with Two (2) Twelve Month options to extend for the furnishing of for Law Enforcement Web Services and other associated services for use by the Sheriff's Office, the Department of Corrections, the Prosecuting Attorney' s Office, Municipal Courts, Drug Task Force and the Family Support Division to Rejis of St. Louis, Missouri as an Acquisition from Other Government. The using departments spend memos are attached. This award is made on an "as needed" basis and does not obligate Jackson County, Missouri to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The County's annual estimated expenditure is \$50,000.00. The Jackson County Compliance portal was checked and the recommended vendor has Status of "Certificate Issued and Emailed to Vendor" certificate showing 12/31/2026 expiration date.
