Mike Sanders, County Executive, said they will seal the time capsule on Saturday, May 10, 2014 at 10 A.M. on the steps of the Historic Truman Courthouse in Independence, Missouri.

He said earlier today, Robert Hagedorn, the Chief of Staff for the late Congressman Ike Skelton, presented Jackson County Executive Mike Sanders with letters to go into a time capsule. These fascinating documents are from President Harry Truman to Congressman Skelton and his Father.

In the letters, President Truman encourages Ike Skelton, Jr. to run for Congress. There is also correspondence dealing with President Truman's decision not to seek re-election and the naming of a road in his honor.

The time capsule will not be opened until September 7th of 2093 and was designed and painted by Sentenced to the Arts artists.
