

**IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI**

**AN ORDINANCE** appropriating \$4,998,014.00 from the undesignated fund balance of the 2021 CARES Act Fund to allow for an allocation to the University of Missouri - Kansas City, to provide health services and aid vaccination efforts in east Kansas City and authorizing the County Executive to execute a Cooperative Agreement with the University of Missouri - Kansas City, at a cost to the County not to exceed \$4,998,014.00.

**ORDINANCE NO. 5506**, May 10, 2021

WHEREAS, U.S. President Joseph R. Biden, Jr., Missouri Governor Mike Parson, and County Executive Frank White, Jr., have all declared or affirmed, in one form or another, that the ongoing Coronavirus/COVID-19 pandemic is a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its citizens and employees; and,

WHEREAS, an appropriate response by the County to this emergency will require significant expenditures from the County CARES Act Fund, which consists of monies provided by the U.S. Treasury for this purpose; and,

WHEREAS, with the funding provided by this appropriation, the University of Missouri - Kansas City (UMKC) and community partners will establish and undertake the Our Healthy KC Eastside (OHKCE) project to promote and deliver widespread COVID-19 vaccinations and other health services within Kansas City's most socially vulnerable community; and,

WHEREAS, a proposal describing the OHKCE project is on file with the Clerk of the Legislature; and,

WHEREAS, OHKCE will utilize UMKC's, Truman Medical Center's (TMC), and the Black Health Care Coalition's (BHCC) extensive experience in providing health services in community and medical settings in Kansas City's Eastside; and,

WHEREAS, UMKC will be the lead agency for the OHKCE project and will be authorized to subcontract with TMC, BHCC, and numerous other community partners; and,

WHEREAS, OHKCE will increase vaccination rates amount the most vulnerable populations and increase preventive health services offered from June 1, 2021, through November 30, 2021; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:


