This program provides for 80% funding on eligible costs for the project. The Local Entity is responsible for the 20% match. The Public Works Department intends to use soft match credit for the Local Entity match resulting is a project that will be 100% funded</p> <p>The Public Works Department has requested funding and received approval from Missouri Highway Department for this project.</p> <p>We request that an ordinance be prepared authorizing the County Executive to enter into an agreement with the Missouri Department of Transportation for the design and construction of the Helmig Road Bridge.</p>
