WHEREAS, the Sheriff's Office has been awarded a grant in the amount of \$500.00 by the Missouri Safety Center for the St. Patrick's Weekend DWI Enforcement Campaign 2011, for the period March 16 through March 20, 2011; and,

WHEREAS, this campaign will increase enforcement of impaired drivers in an effort to reduce fatalities during St. Patrick's Day celebrations; and,

WHEREAS, the Sheriff recommends the use of funds for reimbursement of overtime used for the campaign throughout the County, pursuant to the attached agreement with the Missouri Safety Center; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,

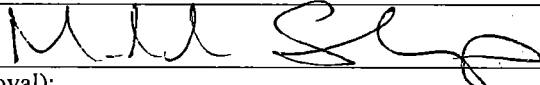

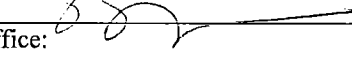
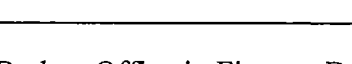

<p>REQUEST SUMMARY</p>	<p>Accept and appropriate \$500.00 from the undesignated fund balance of the Grant fund and authorize the county executive to execute an agreement with the Missouri Safety Division of the Missouri Department of Transportation in the acceptance of the March 16 -20 St. Patrick's Weekend DWI Enforcement Campaign for 2011.</p> <p>The grant is awarded in the amount of \$500.00 and requires no local matching funds.</p> <p>The goal of this campaign is to reduce fatalities and help Law Enforcement agencies throughout Missouri crack down on the crime of drunk driving. On March 17, 2010 Jackson County Sheriff's Office participated in a DWI checkpoint with Kansas City Mo Police Department and the Missouri Highway Patrol, where 829 vehicles were checked and a total number of 44 DUI arrests were made. Jackson County Sheriff's Office participation was made possible through the MoDOT grant funding received last year.</p>
