RESOLUTION #17926, June 18, 2012

INTRODUCED BY Scott Burnett, County Legislator

WHEREAS, section 141.750.2, RSMo 2000, authorizes the Trustees of the Land Trust of Jackson County to convey title in fee simple for consideration less than two-thirds of the appraised value of a property, only after the consent of at least two of the Trustees' appointing authorities; and,

WHEREAS, the City of Kansas City, Missouri, by its Resolution 110072, approved February 10, 2011, has delegated the authority to its Director of Neighborhood and Community Services Department to approve the transfer of blighted properties held by Land Trust of Jackson County to neighborhood-based non-profit corporations for rehabilitation; and,

WHEREAS, by Resolution 17509, dated February 14, 2011, the Legislature did express its support for these efforts of the City Council and staff of the City of Kansas City to reduce blight in the city's urban core; and,

WHEREAS, the City of Kansas City, Missouri Director Neighborhood and Community

Services Department has recommended that the property located at 5001 E. 59th Street, Kansas City, MO, legally described in the attached Exhibit A, be conveyed to Monett Battle of Westport Fund, Inc., of Kansas City (Jackson County), MO, a Missouri non-profit corporation, for restoration to its 1864 appearance as part of the Saving Kansas City's Battlefield Initiative; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Land Trust Trustees be authorized to convey the property located at 5001 E. 59th Street, Kansas City, MO, for an amount of less than two-thirds market value, to the Monett Battle of Westport Fund, Inc., a Missouri non-profit corporation, for the purpose of better maintaining this property and revitalizing the area in which it is located; and,

BE IT FURTHER RESOLVED that the County Legislature of Jackson County, Missouri, encourages the Land Trust Trustees to include and enforce reversionary clauses in the conveyances regarding redevelopment of the properties within a prescribed time frame; and,

BE IT FURTHER RESOLVED that Land Trust Trustees are hereby authorized to execute any and all necessary documents to convey the above-described property for less than two-thirds market value.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.



Narrative of Our Plans for the Property

We launched the Saving Kansas City's Battlefield initiative in 2006 with the purposes of restoring and reclaiming one of the few remaining significant sites associated with the Battle of Westport. The Battle of Westport occurred in Jackson County Missouri on October 21-23, 1864. The battle is the largest battle of the Civil War fought west of the Mississippi. Our overall plan is to remove and restore the flood plain along the Big Blue River at the Byram's Ford crossing. The Ford was placed on the National Register of Historic Places in 1989. With the removal of nine modern buildings in the flood plain we intend to seek the expansion of the area of the original National Register Site to include the Meadow area where the subject tract is located along with the Bloody Hill area to the west of the flood plain and approaching the site of the Kansas City Water Services Department. The Battle of Westport involved 30,000 troops over the three day engagement. It is far and away the most significant Civil War event in Missouri with the exception of the Battle of Wilson's Creek. It has been ranked as a Class A battlefield, the highest rating by the National Park Service; however, the subsequent urbanization of most of the battlefields have made restoration infeasible except at Byram's Ford.

Our Saving Kansas City's Battlefield initiative of which the subject property is included will result in the removal of the industrial park from the battlefield and restore this Hallowed Ground to its 1864 appearance as a Meadow, as described by the battle participants. A goal of the restoration is the conduct of a planned battlefield commemoration and re-enactment upon the site. We have pursued this goal in association with the Kansas City Parks Department.

As noted on the following history of our organization, for the past 30 years we have accumulated through donation and purchase a substantial portion of the Byram's Ford site. In turn, we have donated these parcels to the Kansas City Parks Department for the creation of the Big Blue Battlefield Park. We have acquired an adjacent tract at 5951 Manchester for the same purpose of the removing the building. We are currently conducting a fundraising campaign to retire the indebtedness on the 5951 property in order then remove the warehouse upon that tract. We have worked with the Parks Department to also obtain a Transportation Enhancement grant in order to seek obtain the property at 5950 Manchester. The 5950 property adjoins the subject tract at 5001 E 59th.

As a result of the acquisitions of the three properties at 5001 E. 59th, 5951 Manchester and 5950 Manchester, we will have acquired and removed a total of six of the original nine buildings that stood on the battlefield in 2002.

The donation of the Hallowed Ground of this subject tract will provided a vivid monument to the courage and blood of the participants. The public will gain a greater appreciation that our community was the site of an epic struggle during this chapter of our turbulent history that ultimately produced the vibrant community and nation that followed the end of the Civil War. The public will see and appreciate that men fought and died on this site nearly 150 years ago that we might have the freedoms that we enjoy today.

Narrative of plans

1. Previous similar projects and their outcomes

History of Monnett Battle of Westport Fund

Dr. Howard N. Momett of the Civil War Round Table of Kansas City in 1964 wrote the book *Action Before Westport* which recounted the story of the Battle of Westport of 21-23 October 1864, the largest engagement west of the Mississippi. Dr. Monnett's enthusiasm for the subject within the Round Table led to the discussion of creating an automobile tour of the widely dispersed battle sites.

As a memorial to his vision, in 1975, members of the Kansas City Round Table formed the Howard N. Momett Battle of Westport Fund, Inc. as a 501(c)(3) tax-exempt charitable organization to mark and interpret the sites associated with the Battle of Westport. By 1979, the founders of the Fund had raised \$25,000, erected permanent monument markers at 25 sites and created a self-guided 32-mile automobile tour. The Fund's principal challenge has been to interpret the battlefield which has been mostly overtaken by the subsequent urban development of Kansas City, Missouri.

Since 1979 the Fund's preservation efforts have focused on the reclamation of the Byram's Ford site which was damaged in the 1950s by an industrial park development. In 1983 the Fund obtained a donation from Commerce Bank of fifty acres of the battlefield including the Byram's Ford crossing on the Big Blue River. The Fund's leaders in 1989 obtained the designation of the site as the Byram's Ford Historic District on the National Register of Historic Places. In 1985 the Fund laid out a self-guided walking tour with way posts and a map of the Byram's Ford battlefield.

The Byram's Ford Road Site of the Historic District covering 40 acres was acquired for \$42,000 by the Fund and APCWS, predecessor to the Civil War Trust, in 1995 through a joint fund raising campaign. The leaders of the Fund obtained the agreement of the Kansas City Parks Department to assume the stewardship of these tracts of Hallowed Ground totaling more than 100 acres of the battlefield. In April 1995 the Fund and the APCWS deeded the land to the Parks Department for use as the Big Blue Battlefield Park. The Fund deeded another three acres to the Parks Department in 2002. As a result a corridor stretching for a mile along the Byram's Ford Road across the battle field from the bluffs on the east side of the Blue River to the crest of Bloody Hill came within the public domain except for one tract known as the DuPont property.

In response to plans by the City and Corps of Engineers to alter the river channel and obliterate the historic Byram's Ford site, the Fund's leaders negotiated a compromise plan in 1992 which prevented the destruction of the Ford. In 1995 and 1997, the Fund sponsored archaeological surveys of the site. The 1995 Gray and Pape study funded by the Fund and the City's Historic Preservation Department outlined the areas of the battlesite for protection.

The Fund's Chairman in 2002 wrote an Interpretive and Development Plan for the Byram's Ford (available on the web at www.battleofwestport.org/Plan.htm) which

provided for acquiring additional tracts and restoring the site to its 1864 appearance. The City's Greenway Study in 2005 adopted the Fund's Plan to restore the field to its 1864 appearance. As part of the Plan, the Fund obtained a grant through the City's PIAC program for \$30,000 for installation of a replica cannon on Bloody Hill. As another part of the Plan, the Fund obtained funding for the engineering drawings for the construction of a pedestrian walking trail along the Byram's Ford Road and the crest of Bloody Hill. The drawings were completed in 2008. The Fund is working with City agencies to implement its construction.

In 2006 the Fund launched its Saving Kansas City's Battlefield initiative which is a program designed to reclaim all of the Byram's Ford site south of 59th. Street on which eight buildings of the industrial park then were standing. The Fund's initiative received the enthusiastic endorsement of the City Park Board in October 2006. Director Shirley Christian and the Fund Chairman Smith co-chair this funding and acquisition effort, A video showing the Saving Kansas City's Battlefield project result is on the web at www.battleofwestport.org/Video.htm.

The Fund has made substantial progress on its Saving Kansas City's Battlefield reclamation initiative. Three of the eight buildings are now taken care of. Two of the buildings have been removed. In 2010 the Fund obtained donations of \$100,000 for the acquisition of a third property at 5951 Manchester in the heart of the battlefield and took title to the property in December 2010. The Fund is now conducting further fund raising in order to pay off the \$150,000 mortgage on the land so that the warehouse can be removed. A fourth building, the DuPont property, is articipated to be acquired in the near future. In 2007 the Fund's Chairman prepared a successful grant for \$498,000 from MoDOT and a grant for \$150,000 from the City's PIAC program for the acquisition of the former DuPont. Completion of the acquisition of the property is underway.

Another major project of the Fund is the Battle of Westport Visitor Center and Museum located in Swope Park near the Byram's Ford site. The Fund conducted the Grand Opening of the center in October 2008 at which Congressman Cleaver was the keynote speaker. The Fund's members have volunteered countless hours to the development of displays and sharing the stories of the battle with visitors to the center from April to October each year. action at Byram's Ford. The CWSAC incorrectly included that action as
part of the Byram's Ford battlefield (MO026). The ABPP therefore

The ABPP made extensive revisions to the 1993 Study Area. The Study Area now reflects the following: 1) the Federal approach route from the east; 2) the action at Byram's Ford on October 23rd; 3) troop movements to the east; 4) fighting to the west along and over the Missouri-Kansas state line; 5) the movement of Price's wagon train to the south from the Byram's Ford area; 6) retreats and advances over open ground toward the Confederate wagon train; 7) skirmishing toward, and the action at, Mockbee Farm; 8) the Confederate route to and across Russell's Ford; 8) the skirmish south of Russell's Ford along the Confederate route of withdrawal; and 9) the Confederate route of withdrawal to the south (the boundary extends only as far as the ABPP was able to identify the course of the historic road to Little Santa Fe).

The ABPP expanded the 1993 Core Area to represent the following areas of engagement: 1) fighting at Byram's Ford on October 23rd; 2) fighting north and south along Brush Creek; fighting to and along the Missouri-Kansas state line; 3) heavy fighting as the Confederate forces began to fall back from Westport (unwittingly) toward Pleasonton's division; and 4) Shelby's last defensive position along a series of stone walls running east-west.

In addition, the ABPP established two new Core Areas. The central Core Area represents the location of the Union attack near the Confederate wagon train and the running battle across the landscape to Mockbee Farm (this action is not to be confused with the Mockbee Farm action on October 22nd). The southern Core Area represents the Federal assault on the Confederate wagon train (which was repulsed).

I am pleased to add my support and endorsement of the Monnett Fund's Saving Kansas City's Battlefield initiative. I read with interest (particularly given my own family history) the article in the Kansas City STAR (January 8, 2007, p. B4). It is clear that efforts to save historic sites are essential to our understanding of history.

The Monnett Fund is to be commended for its longstanding efforts to commemorate and preserve this land associated with the 1864 Battle of Westport. From your presentation last year and my subsequent visit to the site for the dedication of the battlefield, I have learned much more about the significance of this site. It is indeed hallowed ground.

I concur with the endorsement made by the Kansas City Board of Parks Commissioners, and join others who support your program of land acquisition and reclamation of the Byram's Ford site for restoration as a significant Civil War battlefield. The Parks board's resolution of October 31, 2006 reflects my view of the importance of your project, and I hope this project can be completed successfully.

Major development activity is reviving a once moribund city; to complement this development, I think the restoration of the Byram's Ford site as a green space and its preservation of the battlefield is an important pursuit. I support and endorse your recently announced Saving Kansas City's Battlefield initiative.

In my role as chairman of the National Trust for Historic Preservation, I have been privileged to see many examples of commendable efforts to reclaim and restore historic properties and landscapes. I understand your Saving Kansas City's Battlefield initiative is comparable to the restoration work being accomplished at the Franklin Battlefield in Tennessee, a site like Westport, which has been ravaged by the encroachment of the urban landscape.

Through these efforts the historic landscapes of the battlefields of the Battles of Westport and Franklin will once again be made tangible for this and future generations.

The Battle of Westport which raged for three days in October 1864 was the largest Civil War battle fought west of the Mississippi River. The National Park Service's Civil War Advisory Committee has ranked the Battle of Westport among the nation's 25 most significant Civil War battlefields.

Unfortunately, many of the sites associated with the Battle of Westport have long been lost to urban growth during the past century and a half. With your Saving Kansas City's Battlefield initiative, our community has an historic opportunity to reclaim a significant portion of the Westport battlefield.

I have a deep personal interest in the history of this community and join in supporting the endorsement of your initiative by the Kansas City Parks Board in its Resolution 27863 of October 31, 2006. As noted by the resolution, the Saving Kansas City's Battlefield campaign will remove the warehouse buildings which lie in the core area of the battle field. The initiative will restore the Byram's Ford battle site to its original 1864 appearance.

Several of these warehouses in this area have been vacated and become deteriorated. In November 2006, the DuPont Corporation vacated its warehouse facility at the Byram's Ford site.

The acquisition and removal of the DuPont warehouse is critical to the restoration of the battle site. We need to act urgently in order to seize the opportunity now that the DuPont property is being offered for sale. Our community has a rare chance to redevelop this declining twentieth century industrial park into an important historic site and cultural resource.

The land acquisition and redevelopment goals of your initiative are both attainable and appropriate. Once acquired, these properties would be available for inclusion in the adjacent portion of battlefield which is currently administered by the Kansas City Parks Department. This municipally administered battlefield is located in the Byram's Ford Historic District of the National Register of Historic Places. The removal of the non-contributing elements presented by the vacated warehouses will enhance the sense of place and feeling associated with this National Register property.

Reclaiming this hallowed ground will also enhance the community's economic well being by promoting heritage tourism to the area. It can be expected that preservation of historic places like the Byram's Ford battlefield of the Battle of Westport will attract tourists and allied economic benefits. We must always remember that it is Kansas City's unique history- not its warehouses and strip malls - that distinguishes it from other communities. Protecting this unique history will guarantee that Kansas City remains a special place for tourists to visit.

As Richard Moe, president of the National Trust for Historic Preservation, has noted, "A battlefield can literally change your life. Of course, you can read any number of books about the Civil War — but when you visit a battlefield, you can do more than read about history. You can see it and touch it and walk through it. At a battlefield, just as at other kinds of historic sites, history says, This is what happened.' Preservation says, It happened right here."

I want to lend my strong support to your applications for funding assistance by you and your partners in this initiative. As outlined by your initiative, you are applying for assistance from the following:

Missouri Department of Economic Development tax credit programs including the Neighborhood Assistance Program (NAP);

Public Improvements Advisory Committee (PIAC) program of Kansas City Missouri; and

In my role as Midwest Coordinator of the American Battlefield Protection Program of the National Park Service, I have had the opportunity to work with the Monnett Battle of Westport Fund since the inception of the program. You have a well deserved reputation for diligence and solid work in the efforts to protect and preserve the historic sites associated with the Battle of Westport.

The Battle of Westport which took place on October 21 through 23, 1864 ranks as one of the 25 most significant battles of the Civil War. It was the largest engagement west of the Mississippi River. Sadly, city growth has engulfed large portions of the hallowed ground at Westport over which the Confederate and Union forces grimly contested for control of the State of Missouri.

Although much of the Battle of Westport has been irretrievably lost to us, your recently announced Saving Kansas City's Battlefield initiative is welcome news.

I appreciated the opportunity in September 2006 to view your video presentation of the Saving Kansas City's Battlefield initiative and to tour the battlefield at Byram's Ford with members of the Monnett Fund. The proposed reclamation and restoration of the Meadow area of the battlefield from the Byram's Ford crossing to Bloody Hill will allow present and future generations to experience a significant portion of the Battle of Westport as it was in October 1864.

As the Midwest Coordinator of the ABPP, I join with others in supporting and endorsing your initiative. The events at Byram's Ford were pivotal to the final outcome of the Battle of Westport and Price's Missouri Expedition.

It was at Byram's Ford on October 22, 1864 that the intrepid Confederate General Jo Shelby was finally able to make a break out and avoid having the entire Confederate

Army crushed between the Blue River and the Federal advance from Independence. The events at the Ford were even more critical on the next day October 23, 1864. The Confederate cavalry fought doggedly across the fields west of the Ford from before dawn to nearly noon in order to hold back the Federal pursuit by General Alfred Pleasonton. Only after intense assaults and mounting casualties, Confederate General Marmaduke was compelled to withdraw his forces to the south and west from the Byram's Ford Road. This action compelled the remainder of the Confederate army at Westport to break off the engagement and retreat.

It is imperative that your initiative be funded as soon as possible. The recent availability of the DuPont warehouse for purchase should be acted upon in order to protect the corridor of the Federal and Confederate armies' paths along the Byram's Ford Road from the Ford across the Meadow to the top of Bloody Hill. Only the former DuPont warehouse now remains in the viewshed from the tope of Bloody Hill at the center of the Confederate battle line as one looks east toward the crossing of the Blue River at the Ford. Hopefully this chance to complete the restoration of this historic view will not be lost other interests.

As outlined by your initiative, you are applying for funding assistance from the following agencies among others:

Missouri Department of Economic Development tax credit programs including the Neighborhood Assistance Program (NAP);

Public Improvements Advisory Committee (PIAC) program of Kansas City Missouri; and

Transportation Enhancement program through the Mid America Regional Council (MARC) and the Missouri Department of Transportation (MoDOT).

Description of Funding to Execute Project

The Monnett Battle of Westport will obtain cash donations and in kind donations for the demolition of the abandoned building on the subject tract and removal rubbish from the site left from previous use a moving and storage facility. The anticipate cash expenditures are estimated to be approximately \$20,000 to \$30,000 based on prior experience in removing other adjacent buildings from the battlefield. We do not anticipate any hazardous materials based on recent environmental studies conducted on adjacent tracts. We plan on completing the work necessary for donating this tract ultimately to the Big Blue Battlefield Park of the Kansas City Parks Department from private sources.

How Long Has Property Been In Land Trust

This tract accumulated substantial delinquent taxes beginning in 2006. Because the previous owner obtained bankruptcy protection, the property continued to accumulate significant unpaid tax liability. As a result foreclosure of the property was delayed. The subject property foreclosed upon in 2011and went to tax sale in August 2011 sale. No bids were received for the property at the 2011 sale. The property was formally transferred to the Land Trust in March 2012 by Order of the Circuit of Jackson County, Missouri. At the time of the tax sale, the amount of tax delinquency for this tract was in excess of \$100,000.00.

History of Preservation

First Efforts - 1920s

In 1923, the Mayor and City Council of Kansas City adopted ordinances encouraging the preservation and marking of the sites associated with the Battle of Westport along Brush Creek in the Country Club District and along the Blue River at the Byram's Ford Crossing.

Efforts to create a National Military Park at Loose Park and at Byram's Ford were pursued in 1926 in the United States Congress. Unfortunately, the Great Depression overwhelmed these efforts.

Formation of Monnett Battle of Westport Fund - 1970s

In 1975, members of the Civil War Round Table of Kansas City banded together to form the Monnett Battle of Westport Fund, nonprofit corporation.

Named in honor of the late Dr. Howard Monnett, who was the author of the Action Before Westport, the Monnett Fund raised \$25,000.00 in contributions to purchase and place markers along a 32 mile auto tour of the sites of the Battle of Westport.

Initial Land Acquisition of Battlefield - 1983

In 1983, Commerce Bank donated to the Monnett Fund separate tracts totaling 50 acres within the site of the battlefield at Byram's Ford. The Monnett Fund later led a successful effort to place tracts of the Byram's Ford Historic District on the National Register of Historic Places in 1989.

With the Association for the Preservation of Civil War Sites, a predecessor to the present Civil War Preservation Trust, the Fund raised over \$40,000.00 in 1992 to acquire another critical 80 acres containing parts of the National Register site. Commerce Bank in 1995 donated another three acre tract of the battlefield to the Monnett Fund.

Byram's Ford Big Blue Battlefield Development Plan - 2002

Between 1995 and 2002, the Monnett Fund transferred its battlefield tracts to the Kansas City Parks Department for development and maintenance as the Big Blue Battlefield.

The Monnett Fund published its Big Blue Battlefield Interpretive and Development Plan which provided an incremental process for creating a viable restored battlefield at Byram's Ford. Click here to view the plan.


Most of the major objectives of this Battlefield Development Plan have been accomplished including:

- Opening of Visitor Center and Museum
