#### 5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, has been working with the City of Kansas City on developing an RFQ and pursuing proposals for an energy performance contract to make energy improvements to the four downtown buildings - (Kansas City Courthouse, Jail, Jail Annex, Criminal Courts/Justice Building). With the City of Kansas City, Jackson County has chosen Johnson Controls. This legislation will be introduced today and in committee next week. The Kansas City Courthouse was built in 1934 and many renovations are needed. Under this agreement, the cost savings are guaranteed to pay for the cost of the renovations. If they don't, the agreement says that Johnson Controls writes us a check. It will also mean the preservation of a historic building built and dedicated by Harry S Truman himself. Katheryn said she would appreciate the Legislature's consideration and support of this matter.

Katheryn reminded the Legislature that Santa-Cali-Gon starts Friday in Independence and runs through Labor Day. She said last year there was an incident with the restrooms in the courthouse on the square. Some people tried to flush diapers down the toilet which caused over \$3,000.00 damage. Therefore, this year the courthouse will be open, but restrooms will be locked. Port-a-potties are available nearby. The courthouse needs to be open to allow access to the Senior Citizen Craft Shop. We have also set up four diaper changing stations in the halls along with eight trash receptacles for the convenience of parents and grandparents with babies and toddlers. She hopes these new amenities will be helpful for those planning to attend Santa-Cali-Gon.

Fred Arbanas, County Legislator, would like the restrooms to be open but suggested that signs be posted to dispose of diapers in the trash. All other legislators agreed. Katheryn said if it was the will of the Legislature to keep the restrooms open, they will be kept open.

Dennis Waits, County Legislator, asked if the second floor of the courthouse would be closed. Katheryn responded yes.

Dan Tarwater, County Legislator, asked if outside entities will be selling parking spaces using county parking lots. Katheryn Shields said she was not aware that anyone would be doing this. Victor E. Callahan agreed.

Katheryn asked Jane McQueeny, County Counselor, to provide a brief update on the progress of reapportionment.

Jane McQueeny, County Counselor, reported that Judge Torrence began the process to have a reapportionment committee start over again pursuant to the Jackson County Charter. The county filed the declaratory petition on Tuesday and he entered his order on Friday afternoon. The judge agreed to hold an informal meeting at 11:00 a.m. with the parties on Wednesday. Both election authorities appeared and were concerned about the reapportionment process beginning over again because of the time element. Election authorities advised the court that they did not think the reapportionment committee would be successful and were in favor of the judge drawing the lines. The county's position was that the reapportionment process should begin again. The judge suggested shortening the length of the process. A meeting was held with the attorneys' from the election boards and a tentative agreement on dates was reached. The judge agreed to reconvene on Friday for a hearing. The proposed order shortened the time frame for the reapportionment process so the election authority could conduct their elections. On Friday, Jane received a memo from Chairman Callahan that said he was not in favor of that order. The judge was informed of this and told that the county could not support the order as issued. The Judge then heard arguments. The Democratic party intervened through their attorney and Tom Wyrsch, attorney's from the election boards were heard and the Republican Party attorney was present but did not intervene. All parties agreed the time frame could be shortened. The judge entered an order on Friday afternoon and Jane sent the order to the Legislators. A time line was distributed regarding this process which goes through October 31, 2001. Katheryn Shields notified both parties, by letter on Friday, August 24, 2001, to begin the selection process again. They have 30 days to report back to the County Executive. The County Executive has five days to select from the nominations. The reapportionment committee then has 30 days to redistrict. There is a 15 day interval for the committee to report to the court on their progress. Jane felt that we were very successful.

Victor E. Callahan, Chairman said the Legislature passed a written motion last Monday instructing Jane McQueeny, County Counselor, to follow Section 18 of the County Charter and prior legal precedent. At the legislative meeting last week, the County Counselor and the County Executive agreed. He then found out on Friday that Jane had submitted an order, without informing any member of the Legislature, in which she changed many of the time frames. He was disappointed, as her client, that he was not kept informed. He was not advised of her conference with the judge. In response to his memo regarding her order which was contrary to the legislative motion, Jane wrote she disagreed that she violated the authorization in the motion. It did not say anything about time frames. Victor advised Ms. McQueeny that the entire Section on reapportionment on page nine of the charter and the precedent set in 1992 deals with time frames.

Jane advised the Legislature that they were under tremendous time pressure to get this resolved. If the lines are not redrawn, there are serious ramifications. She apologized and said she tried to keep Chairman Callahan informed. She said she faxed a copy of the proposed order.

Victor E. Callahan interrupted to say he spoke with Jane on Tuesday and never heard from her again until he saw her on Friday. He said he spoke with Jay Haden, Deputy County Counselor, every day and he never mentioned anything. He received a fax of her order on Friday which was negotiated on Wednesday.

At Judge Torrence's direction, Jane met with the attorneys' of the election boards and let the representatives of the parties know about the discussion. Then late Wednesday, at approximately 4:30 p.m., she faxed the proposed order to both Ralph Monaco, attorney representing the Democratic Party and Bunk Farrington, attorney representing the Republican Party and both attorneys' for the election boards. Thursday morning she was at meetings away from the office and was then called away for a family emergency on Thursday afternoon. Therefore, the first time she had to revisit this issue was Friday morning from home. She said the proposed order was sent to Mr. Callahan by interoffice mail on Wednesday afternoon. She called her secretary on Friday morning and asked that she fax the order to the Chairman.

Victor asked why she didn't fax it to him on Wednesday afternoon. She was instructed by the County Legislature and agreed publicly to follow a certain course of action and wanted to know why she did not think to advise her clients (members of the Legislature) when she changed the course of direction as given.

Jane said she felt that she was operating within the spirit and intent of the Legislature.

Victor said he was disappointed in the way Jane handled this case. She failed her client, the Jackson County Legislature. Also, once again, she and the County Executive publicly agreed to do something and then privately undid it. It is very difficult to work together with people who do this. Jane should have advised the Legislature that there was a meeting with the judge and that time frame was an issue.
