WHEREAS, it was in 2011 that Ruth retired from the Jackson County Courthouse after serving for over 25 years in the Jackson County Legislative office and various departments; and,

WHEREAS, she was a spiritual and faithful member of the Metropolitan Spiritual Church of Christ, where, in 2011, she had the honor of serving on the Board of Trustees; and,

WHEREAS, Ruth had the joy of helping other people in her community; and,

WHEREAS, she was known for looking flawless, always having her hair and nails done, along with her beautiful clothing choices; and,

WHEREAS, Ruth, they say, was a diva since birth, when asked about her age, she would always say, "39 and holding"; and,

WHEREAS, Ruth leaves behind a daughter, her son-in-law, a granddaughter, and many nieces and nephews to shine in her legacy; now therefore,
