TITLE: Awarding a Twelve (12) month term and supply contract with an end date of June 30, 2027, for the furnishing of Personal Computers, Miscellaneous Computer Hardware, Software, Maintenance and Professional Services for various County Departments to Software House International (SHI) under the terms and conditions of the State of Missouri Contract Number CT220337001, an existing government contract.

SUMMARY: Various County Departments require a Term and Supply Contract for the purchase of Personal Computers, Miscellaneous Computer Hardware, Software to purchase new equipment and software as necessary while providing maintenance for existing equipment. This is an SHI PC Prime Vendor Services Contract offering desktop computers, portable computers and peripherals, data center technologies, software and software maintenance to include Manufacturer-Provided and Contractor-Provided Value-Added Services. IT also has a requirement of Professional Services on an "as needed" basis. The Director of Finance and Purchasing recommends the approval of the contracts due to a higher volume discount offered to larger entities and purchasing groups. Pursuant to Section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the awarding of Term and Supply Contracts for the furnishing of Personal Computers, Miscellaneous Computer Hardware, Software, Maintenance and Professional Services for use by Various County Departments to Software House International (SHI) under the terms and conditions of the State of Missouri Contract Number CT220337001 an existing competitively bid other-government contracts: This award is made on as "As Needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriation. The annual estimated spend is \$50,000 The Jackson County Compliance Portal was checked, and it was confirmed that a 2026 Compliance Certificate was

issued.
