**TITLE:** Awarding a Term and Supply contract from January 1, 2025 through December 31, 2027 (this matches awarded contract term and aligns with existing contract term end date of 12/31/2024) with two (2) additional one-year renewal options for the furnishing of Maintenance, Repair and Operational (MRO) Supplies, Parts, Equipment, Materials and Related Services for various County departments to W.W. Grainger, Inc. under the terms and conditions of the City of Tucson, AZ | Omnia Partners Contract No. 240078-01, an existing competitively bid government contract.

**SUMMARY:** Various County Departments require a Term and Supply Contract for the furnishing of Maintenance, Repair and Operational (MRO) Supplies, Parts, Equipment, Materials and Related Services. The County will access the competitively bid contract awarded to W.W. Grainger by the City of Tucson, AZ | Omnia Partners Contract No. 240078-01. The Contracts Executive Summary and category discount sheet are attached. Pursuant to Section 1030.4 of the Jackson County Code, Competitive bidding shall not be required when the items purchased are the subject of existing and current federal, state, or local government fixed price contractual document. The Director of Finance and Purchasing recommends awarding a Term and Supply contract from January 1, 2025 through December 31, 2027 with two (2) additional one-year renewal options for the furnishing of Maintenance, Repair and Operational (MRO) Supplies, Parts, Equipment, Materials and Related Services to W.W. Grainger under the terms and conditions of the City of Tucson, AZ | Omnia Partners Contract No. 240078-01, an existing, competitively bid government contract. In purchasing off this existing agreement, Jackson County is achieving cost-effective and efficient acquisition of quality products and services. This award is made on an "as needed" basis and does not obligate Jackson County, Missouri to pay any specific amount. The availability of funds for
