TITLE: *An ordinance appropriating \$25,000 from the undesignated fund balance of the 2025 Delinquent Sales Tax Fund and authorizing the Prosecuting Attorney to execute a Cooperative Agreement with Michael Mansur, of Kansas City, MO, for the SAVEKC Project, at a cost to the County not to exceed \$25,000.*

SUMMARY: The SAVE KC collaboration is strong, bringing together community leaders, service providers, pastors, and other key voices. However, to continue building these vital partnerships and sustaining commitment to our shared mission, additional support is needed. To provide temporary continuity, Michael Mansur will take on the following tasks and deliverables to strengthen SAVE KC and expand its impact:

- Maintain and grow the efforts of SAVE KC's Messaging Committee, including the development of new intervention strategies targeting juveniles.
- Support SAVE KC's engagement with local and national funders and supporters to enhance resources and partnerships.
- Ensure progress with SAVE KC's new relationship with a fiscal agent while fostering additional partnerships with other promising violence-reduction initiatives in Kansas City.

The term of this agreement will be six months, with a maximum cost not to exceed \$25,000. The contract will be billed monthly.
