WHEREAS, in addition to playing the clarinet, Alexander has also been a drum major for three years and has played the piano since the fourth grade, earning an Honorable Mention at the Missouri Federation of Music Clubs state competition; and,

WHEREAS, in 2011, Alexander traveled to Europe with People-to-People, an international organization founded by President Dwight D. Eisenhower to bring understanding and friendship through educational, cultural, and humanitarian activities among peoples of different countries and diverse cultures; and,

WHEREAS, Alexander looks forward to earning an advanced degree in music education and teaching at the university level; and,

WHEREAS, Alexander's parents, Brian and Margaret Lynn, and his brother Christopher, are justifiably proud of his accomplishments; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature hereby congratulates J. Alexander Lynn upon his selection to perform in the All-National Concert Band, and extends best wishes to him in all of his future endeavors.
