Request Summary

The Mid America Regional Council is seeking financial and staff participation in the Kansas City Regional Electric Vehicle Readiness Planning project. The \$10,000 cost to the County will fund a portion of the local match necessary to utilize federal transportaion grant funds paying for the project. The planning project will facilitate the following objectives:

- The project will engage regional stakeholders and the public in the planning of the transition to vehicle electrification.
- Identify current interests, needs, and barriers among stakeholders in electric vehicle and electric vehicle supply equipment expansion.
